Cohort

The Fall 2009-10 cohort file, CCxx.IPEDS.OM.2010.txt (where xx is the institution number), will be sent to your college via TIBCO by the Bureau of PK-20 Education Reporting and Accessibility (PERA). Download the file to a secure area.

NOTE: files with invalid filenames will be rejected by the server and deleted.

The file and completed certification form are due by November 15, 5:00 p.m. EST.

Include **ONLY** those records of students in the cohort who are deceased. If your college has no deceased students in the cohort, send only the certification form and indicate "No" in the Submitted column on the form.

Records not in the original cohort will not be loaded.
