Section 1 – Evidence-based Mental Health Services

The Columbia County School District is committed to delivering evidence-based Mental Health services to the students of Columbia County. All Mental Health services are categorized into three different tiers ranging from awareness and prevention to intervention and recovery aim to reduce the likelihood of at-risk students developing social, emotional, or behavioral problems, depression, anxiety disorders, suicidal tendencies, or social anxiety disorders. A referral process for Mental Health services is available to families for students who may struggle with a variety of barriers to learning including social, emotional, and behavioral problems. Four At-Risk Intervention specialist will provide provision of mental health assessment, diagnosis, intervention, treatment, and recovery services to students with one or more mental health or co-occurring substance abuse diagnoses and students at high risk of such diagnoses, decreasing staff to student ratios while attempting to meet student's mental health needs. They will also teach evidence based curriculum to motivate and increase resiliency among students. The At-Risk Intervention Specialist are master level mental health counselors and one school certified counselor. Two fulltime Community Case Managers and one part time District Case Manager who work with the students, parents, schools, and community partners to provide services, accountability, tracking of outcomes. Intervention staff are strategically placed at school showing the highest demand for direct mental health services. Staffing placement allocations are reviewed continuously in order to meet school and student needs.

Tier 1 programs seek to address mental health issues at the awareness and prevention levels. These programs are designed to be implemented with the faculty and staff and/or the student body of the entire school. Tier 1 programs are not intended to isolate individual cases of mental health, but provide training and programs in order to create an awareness of mental health issues and provide a forum for individuals who may need further assessment to be identified and referred.

- I Am Listening is a district-wide awareness campaign that seeks to empower all district employees (administration, faculty, staff, and support staff, full-time and part-time) and all students to listen to and seek the interests of others. This campaign fosters open communication among the district's employees and students.
- Youth Mental Health First-Aid is a 6-hour mental health awareness program designed to train all administration, faculty, and staff personnel in helping adolescents who are experiencing mental health or addiction challenges or are in crisis. The course introduces common mental health challenges for youth, reviews typical adolescent development, and teaches a five-step action plan for how to help young people in both crisis and non-crisis situations.
- Schools will implement character education through various methodologies (classroom management, school announcements, etc.) to assist students with learning basic social skills and manners that will contribute to the overall morale of the student body.
- Monique Burr Foundation (MBF) Child Safety Matters is an elementary and secondary school curriculum that seeks to educate and empower students, school personnel, and parents with information and strategies to prevent bullying, cyber-bullying, digital abuse

- and all types of child abuse. The curriculum includes lessons and activities on topics such as safety and responsibility, safe adults, social and emotional learning, character development, bulling and cyber-bullying, and technology/digital dangers (gaming, virtual reality, and social media).
- Other awareness programs such as Rachel's Challenge, 9th Grade Success Class, Red Ribbon Week, and Strength and Difficulties Questionnaires may be used as needed to promote the well-being of students.
- Sandy Hook Promise Clubs challenge students and teachers to take actions to help build school community and encourage kindness and positivity as well as ending social isolation, bullying, and violence in schools with a simple "Hello".

Tier 2 programs, in addition to general mental health awareness, seek to provide evidence based mental health care treatment to children and include interventions and services to specific groups of students. These programs are implemented by At-risk Intervention Specialists (mental health counselors) or representatives from our partner agencies. Tier 2 programs are not intended to isolate individual cases of mental health need, but provide training and programs in order to create an awareness of mental health issues and provide services to students with one or more mental health or co-occurring substance abuse diagnoses and students at high risk of such diagnoses. It will also provide a forum for individuals who may need further assessment. Coordination of such services with a student's primary care and/or mental health provider will be completed.

- Why Try Program The Why Try program is a resilience education curriculum that
 provides simple, hands-on solutions for drop-out prevention, violence prevention,
 truancy reduction, and increased academic success. It teaches social and emotional
 principles to youth in a way they can understand and remember.
- SBIRT Screening, Brief Intervention, and Referral to Treatment is an evidence-based practice used to identify, reduce, and prevent problematic use, abuse and dependence on alcohol and illicit drugs. It is an approach to screening and early intervention for substance use disorders and people at risk for developing substance use disorders.
- The At-risk Intervention Specialists for each school will organize, implement and provide treatment to At-Risk Students. The At Risk Specialists will provide counseling for social skills, anger management, and other mental health issues as identified among students by parents, school personnel and student's primary care provider.
- The At-risk Intervention Specialists (Mental health counselors) will provide consultation with teachers and parents regarding evidence-based classroom supports and strategies for at-risk students. These strategies will provide treatment and recovery.
- All Star Meridian offers this program to provide At Risk Students a continuum for treatment and recovery, for grades 4-12, with one or more mental health or cooccurring substance abuse diagnoses and students at high risk of such diagnosis.
 Designed to delay the onset of risky behaviors with those At Risk adolescents. All stars aligns with the National Health Education Standards allowing for easy integration into any health or wellness curriculum.

Girls Circle- Meridian- offers this program. Is a structured group for girls from 9-18 years, integrating relational theory, resiliency practices, and skills training in a specific format designed to increase positive connection, personal and collective strengths, and competence in girls. This program provides intervention and recovery services to girls with one or more mental health or co-occurring substance abuse diagnoses and students at high risk of such diagnoses.

Tier 3 mental health services are those services provided to individual students based on recommendations or referrals from school personnel, family members or student's primary care provider. Tier 3 services are implemented individually.

- SBIRT Screening, Brief Intervention, and Referral to Treatment is an evidence-based practice used to identify, reduce, and prevent problematic use, abuse and dependence on alcohol and illicit drugs. It is an approach to screening and early intervention for substance use disorders and people at risk for developing substance use disorders.
- The At-risk Intervention Specialists (mental health counselors) for each school will
 assess, implement, coordinate, treat and provide other mental health services for
 individual counseling. Social skills, anger management, mental health or co-occurring
 substance abuse diagnoses as identified among students by parents and school
 personnel and the At Risk Specialist and other partnering agencies will handle student's
 primary care provider.
- The Community Case Managers communicate with schools, parents, community agencies, and any other providers involved with the student and their family. All services are tracked to ensure the student's continuity of care.
- Students who are identified as needing Tier 3 intervention services are referred to individual counselors or psychologists that are provided by the district's agency partners such as Meridian Behavioral Health Care, Corner Drug store, University of Florida Psychology Department, Haile Market Therapy and Resolution Health Alliance.
- Meridian Behavioral Health Care/Resolution Health Alliance provides an in-school therapist school based on Medicaid availability.

The district coordinates with several local agencies to provide support for addressing mental health needs within the district as well as coordinating services when those agencies are the student's primary care mental health provider. The district employs a district case manager part-time to work with the families of students identified and referred as at-risk students. The case manager assists families with identifying problems and referring to the Mental Health services that best meet their needs. The case manager helps families consider variables such as cost, insurance, transportation, and willingness to participate, all of which potentially affect the effectiveness and outcome of the services provided. The Two fulltime Community Case Managers recommend services for assessment, diagnosis, intervention, treatment, and recovery based on the history and need of the individual. The Case Managers ensure students who are referred for mental health screenings for the identification of mental health concerns are assessed within 15 days of the referral. The Case Managers also verify the school-based mental health services are initiated as needed within 15 days after identification and

assessment, and support by the community-based mental health service providers for students who are referred and initiated within 30 days after the school makes the referral. Outcome feedback forms go to the school personnel and the referral source. The case managers facilitate communication between the agencies, parents, and the district in order to track the student's progress. The District will also track referrals provided to all outside agencies and contracted staff. The schools and district will continue to review and problem solve based on outcome data as provided from climate surveys, Youth Risk Behavior Survey (YRBS) and Focus tracking. The district's agency partners provide the following support services:

- Cognitive Behavioral Therapy This service provides counseling for mental health disorders such as anxiety, depression, substance abuse, and anger management.
- Parent Behavior Management Training This service provides parents with the tools to help their students cope with various behavioral disorders.
- Parent Mental Health Diagnosis Training This service equips parents in understanding mental health diagnosis and implementing interventions.
- Functional Family Therapy This service provides counseling that assists families in dealing with delinquent and disruptive behavioral issues.
- Counseling is also provided to help student develop social skills aimed at making them
 more successful in the classroom as well as solution focused therapy for academic under
 achievement.

Section II – Personnel and Agencies Providing Mental Health Services

Columbia County currently works with several outside agencies to provide Mental Health counseling. Because of the Mental Health Allocation funds, our district will be able to provide more services. Through a referral system, students are identified. These referrals are logged into a database when the Safe Schools Office receives them. Contact is made to the parent and an appointment is made to speak with the District Case Manager. During this meeting, the Case Manager will collect information through a social history questionnaire and process referrals to set up counseling with our partnering agencies. Information is added into the database. A feedback forms provided to the referral source. Each month the outside agency will provide a list of those seen and those released from services.

Section III- Resource Allocation for Mental Health

Columbia County School District received \$341,547 for the 2019-20 school year. From the \$341,547 Belmont Charter School receives \$17,077 (5%) based on FTE. Four At-Risk Intervention Specialists (2 Licensed Mental Health Counselors, 1 MSW, RCSWI mental health counselors and 1 certified school counselor) (\$176,000) and two and 1/2 Case manager (\$120,000) have been hired. The At- Risk position will aid in helping students and parents, identifying student needs

and providing tier 1, 2 and tier 3 supports. The Case Managers will meet with the parents/guardians to determine the appropriate counseling services and coordinate with the student's primary care provider and with other mental health providers. The Director of Safe Schools will receive (\$24,470) to ensure the program coordination of mental health services is done with fidelity and working at it highest potential. Our budget allocation documentation will verify that a minimum of 100% of funds will be spent on coordination of mental health services or direct mental health service and interventions are properly monitored and implemented within our district.

Currently our district places students into our agencies based mainly on the student's insurance provider. Agencies then bill the insurance company directly. Our goal is to not only provide services for those insured but also, assist in helping everyone receive services.

Prevention measures such as Why Try, Why Try Resiliency, All Stars, Girls Circle, Monique Burr, SBIRT, YMHFA, and others are evidence based curriculum to be used as prevention tools in our district.

Columbia County has 14 schools. Currently only 4 At-Risk Specialists (mental health counselors) are providing services to these schools. In order to increase effectiveness there is a need for more specialists. If further funding is provided, Columbia County School's goal would be to place an At-Risk Specialist in each of our schools. As we increase the amount of professionals, we will also have the ability to reach more students.

The need for mental health is increasing at alarming rates. Our district, with the direction of our Superintendent, is working hard to provide services to those students and their families that struggle with Mental Health issues. One hundred percent of state funds are used to expand school-based mental health care, train educators and other school staff in detecting and responding to mental health issues, and connect children, youth, and families with appropriate behavioral health services. Mental health allocation funds do not supplant or other funding sources or increase salaries or provide staff bonuses.
