McKay Scholarship Program

The John M. McKay Scholarships for Students with Disabilities Program allows parents of students with disabilities to choose the best academic environment for their children. This program provides eligible students the opportunity to attend a participating private school or transfer to another public school. Eligible students include students who have been issued an Individualized Education Plan (IEP) or a 504 Accommodation Plan that is effective for more than 6 months. Students must also have been enrolled and reported for funding by a Florida school district the year prior to applying for a scholarship.


Voicing Their Choice

Over the past decade, thousands of parents have chosen the McKay Scholarship Program. During the 2019-20 school year, \$221.5 million was paid to scholarship program participants. The scholarship amount for IEP students enrolled ranged from \$525 to \$25,315, averaging \$8,473. The average amount for students with a 504 Plan was \$4,676.



Student Participation in McKay Scholarship Program




McKay Students by Grade Level



McKay Scholarship Program Remains Popular

Since 2000-01, participation in the McKay Scholarship Program has remained steady. In 2019-20, 30,185 students from 1,547 private schools participated in the program. Private schools participating in McKay must document compliance with eligibility requirements specified in law.

Statutory and Rule References: Student Eligibility:	 s. 1002.39, F.S.; Rule 6A–6.0970, F.A.C. s. 1002.421, F.S.; Rule 6A–6.03315, F.A.C. Public school student counted in the prior school year's October and February FTE surveys, with an IEP or a 504 Plan that is effective for more than 6 months. The student is a foster child or a dependent child of a member of the U.S. Armed Forces who transfers to Florida due to a parent's permanent change of station orders. Students who received Specialized Instructional Services (SIS) under the Voluntary Prekindergarten Program during the previous year. Application Deadlines 		
Deadline for Filing Student Intent:	None. Intent to participate must be filed 60 days prior to the next legislatively set payment date to be eligible for the payment.		
Deadline for Private School Eligibility:	New Schools: Determined by the Florida Department of Education. Renewing Schools: March 1st submit a Scholarship Compliance Form; May 1st for all final documentation.
