# Florida End-of-Course Assessments

## Grades 6-12

The Florida End-of-Course (EOC) Assessments are computer-based, criterion-referenced tests that measure the *Next Generation Sunshine State Standards* (NGSSS) in Biology 1, U.S. History and Civics, as outlined in their course descriptions. The Biology 1 EOC Assessment was administered for the first time in spring 2012; the U.S. History EOC Assessment was administered for the first time in spring 2013; and the Civics EOC Assessment was administered for the first time in spring 2014. This year, Florida transitioned to new end-of-course assessments in Algebra 1, Geometry, and Algebra 2 designed to measure students' mastery of the new Florida Standards in mathematics. These new assessments replaced the EOC assessments that were administered in mathematics (Algebra 1 and Geometry). Administrations of the NGSSS Algebra 1 and Geometry EOC Assessments continue to be offered for graduation and course completion purposes. During the first year of implementation, each new EOC assessment is administered only in the spring. Currently, after the initial spring administration, each EOC assessment is also administered in the summer, fall and winter.

Student results in this media packet include the combined results for the test administrations offered throughout the school year. These assessments are outlined on the notes pages preceding each subject area's section. In addition, student performance in this media packet represents only student results for first-time test takers during the school year.

The success a student has achieved with the NGSSS assessed by the EOC assessments is indicated by Achievement Levels that range from 1 (lowest) to 5 (highest). Achievement Levels are established by the State Board of Education after the first statewide test administration and a standard-setting process that includes educator and stakeholder input. Civics EOC Assessment Achievement Levels were established by the State Board on January 14, 2015. Student performance on the initial year of each EOC assessment presented in this media packet is reported using the adopted Achievement Level standards. This was done so stakeholders can compare school years and see how students would have performed if the Achievement Levels had been established at that time.

The Achievement Level definitions that apply to EOC assessments are provided below, along with the cut scores that define the Achievement Levels for each EOC assessment. The State Board has established the minimum score in Achievement Level 3 as the passing score for all EOC assessments.

- Level 5:** Students at this level demonstrate mastery of the most challenging content of the *Next Generation Sunshine State Standards*.
- Level 4:** Students at this level demonstrate an above satisfactory level of success with the challenging content of the *Next Generation Sunshine State Standards*.
- Level 3:** Students at this level demonstrate a satisfactory level of success with the challenging content of the *Next Generation Sunshine State Standards*.
- Level 2:** Students at this level demonstrate a below satisfactory level of success with the challenging content of the *Next Generation Sunshine State Standards*.
- Level 1:** Students at this level demonstrate an inadequate level of success with the challenging content of the *Next Generation Sunshine State Standards*.

# Biology 1 EOC Assessment Grades 6-12 2014-15 School Year

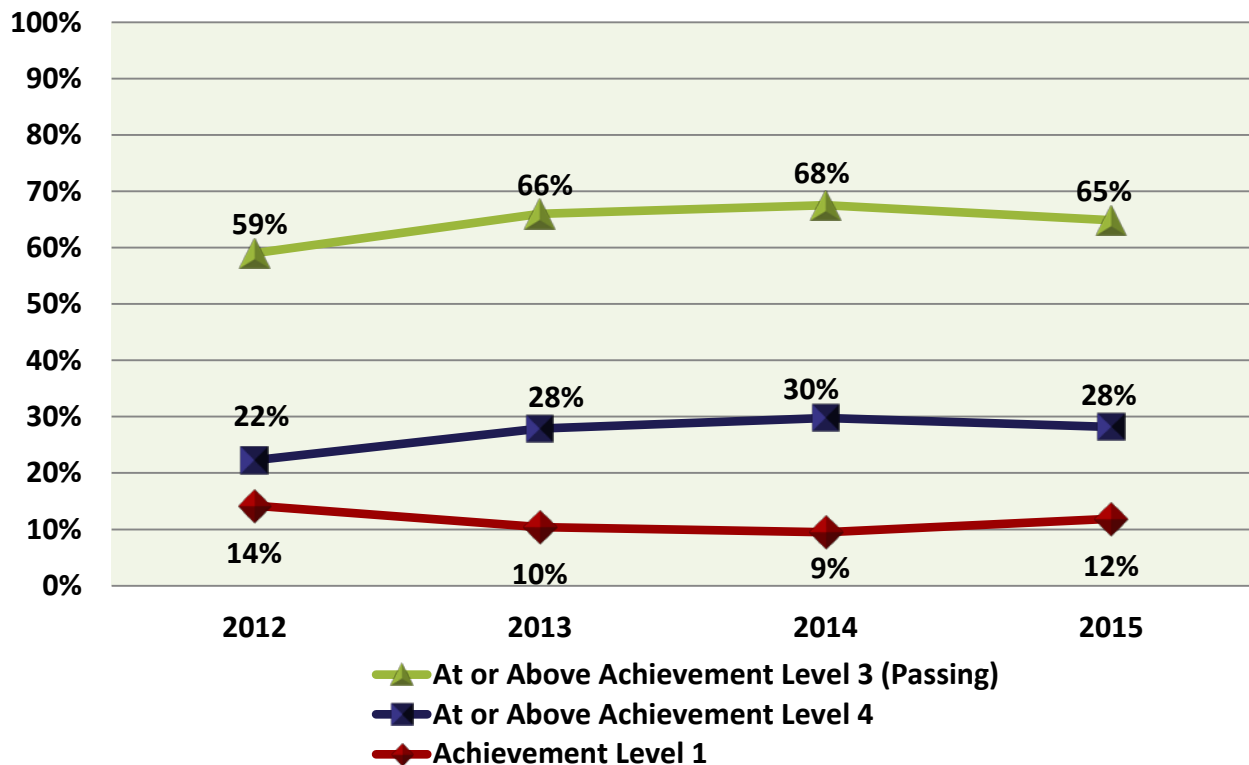
**NOTES:**

This was done so stakeholders can compare school years and see how students would have performed if the Achievement Levels had been established in 2012.
- 2) Percentages displayed in this document for 2014 may reflect minor differences from percentages published in last year's media packet. This is because of the inclusion of summer 2014 results and routine updates made to student data subsequent to last year's release.
- 3) Biology 1 student performance in this media packet includes student results for all first-time test takers for each administration during each school year.

## Grades 6-12 Biology 1 EOC Assessment By Achievement Level

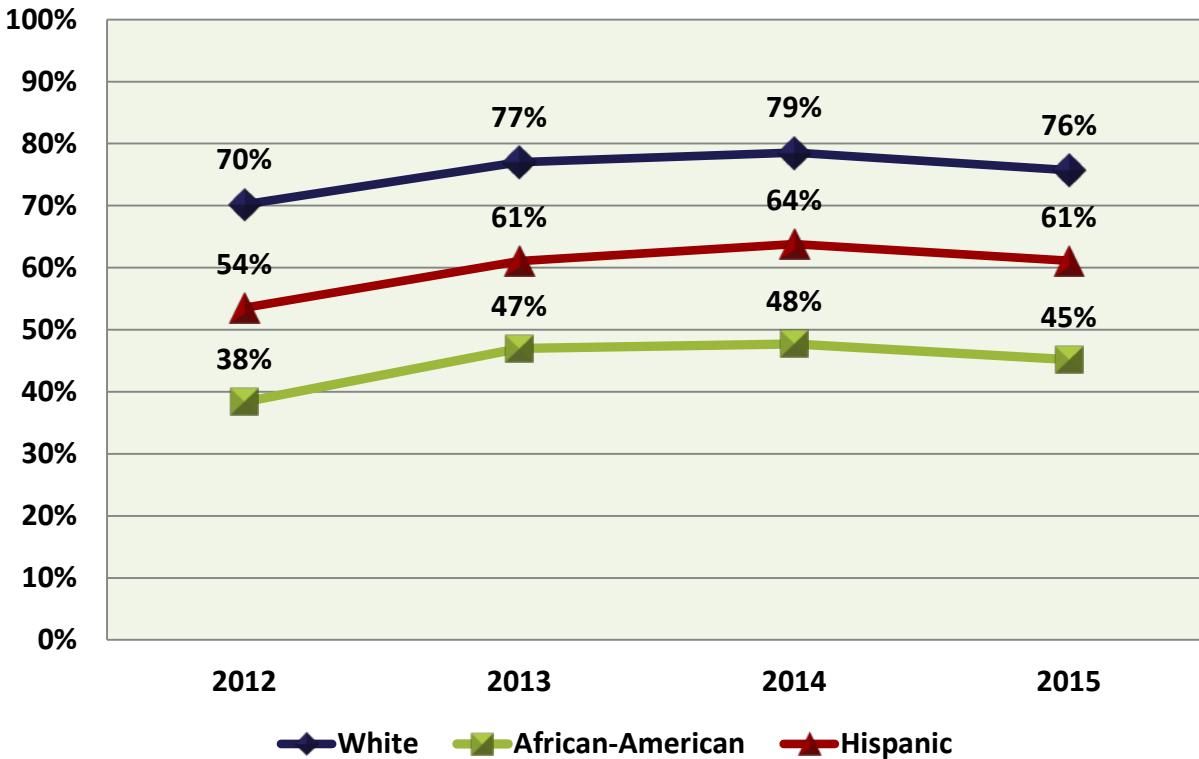


While the percentage of students in grades 6-12 scoring at Achievement Level 3 (Passing) or higher and at or above Achievement Level 4 or higher on the Biology 1 EOC Assessment is 6 percentage points higher than in 2012, performance decreased 3 and 2 percentage points, respectively, from 2014 to 2015.

In 2015, 65 percent of students in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 68 percent in 2014 and 66 percent in 2013 and an increase from 59 percent in 2012. In 2015, 28 percent of students in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 30 percent in 2014, is equal to 28 percent in 2013 and an increase from 22 percent in 2012. In 2015, 12 percent of students in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 9 percent in 2014 and 10 percent in 2013 and a decrease from 14 percent in 2012.

## Grades 6-12 Biology 1 EOC Assessment At or Above Achievement Level 3 (Passing)

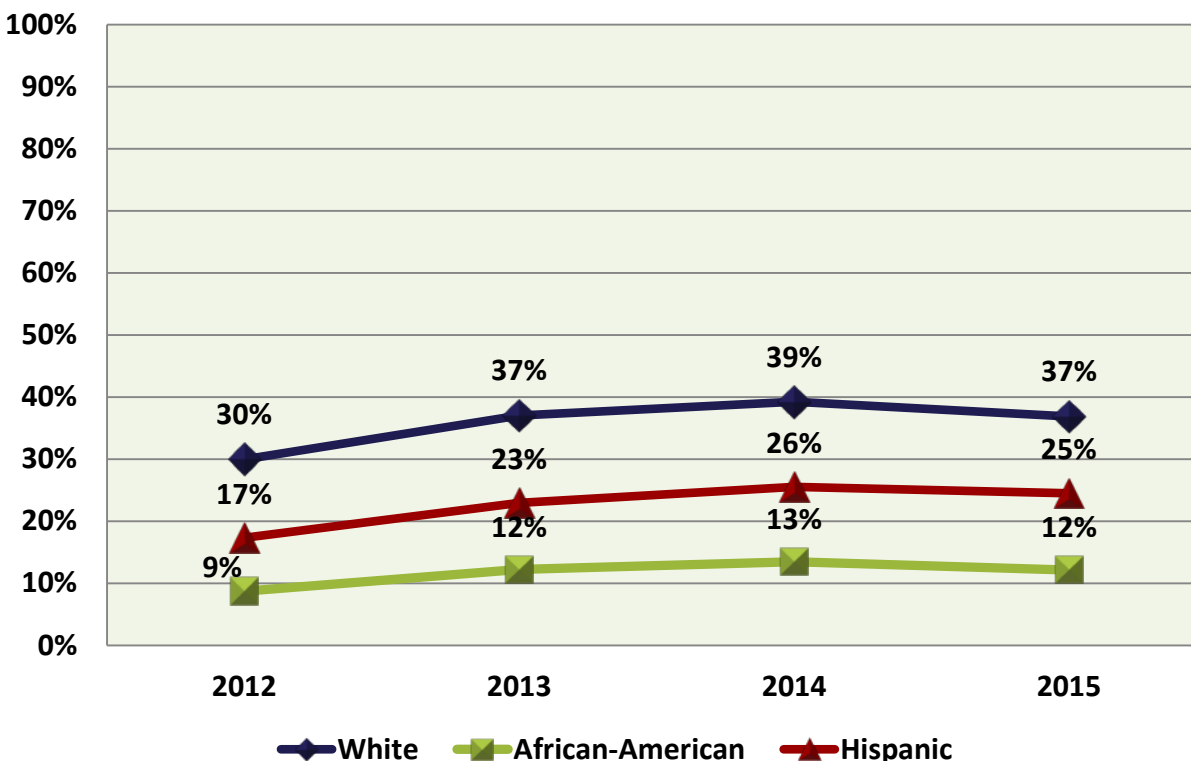


Grades 6-12 performance at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment is 7 percentage points higher for African-American and Hispanic students and 6 percentage points higher for White students than in 2012; however, performance is lower by 3 percentage points for each subgroup from 2014 to 2015.

In 2015, 76 percent of White students in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 79 percent in 2014 and 77 percent in 2013 and an increase from 70 percent in 2012. In 2015, 45 percent of African-American students in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 48 percent in 2014 and 47 percent in 2013 and an increase from 38 percent in 2012. In 2015, 61 percent of Hispanic students in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 64 percent in 2014, the same as 61 percent in 2013 and an increase from 54 percent in 2012.

## Grades 6-12 Biology 1 EOC Assessment At or Above Achievement Level 4

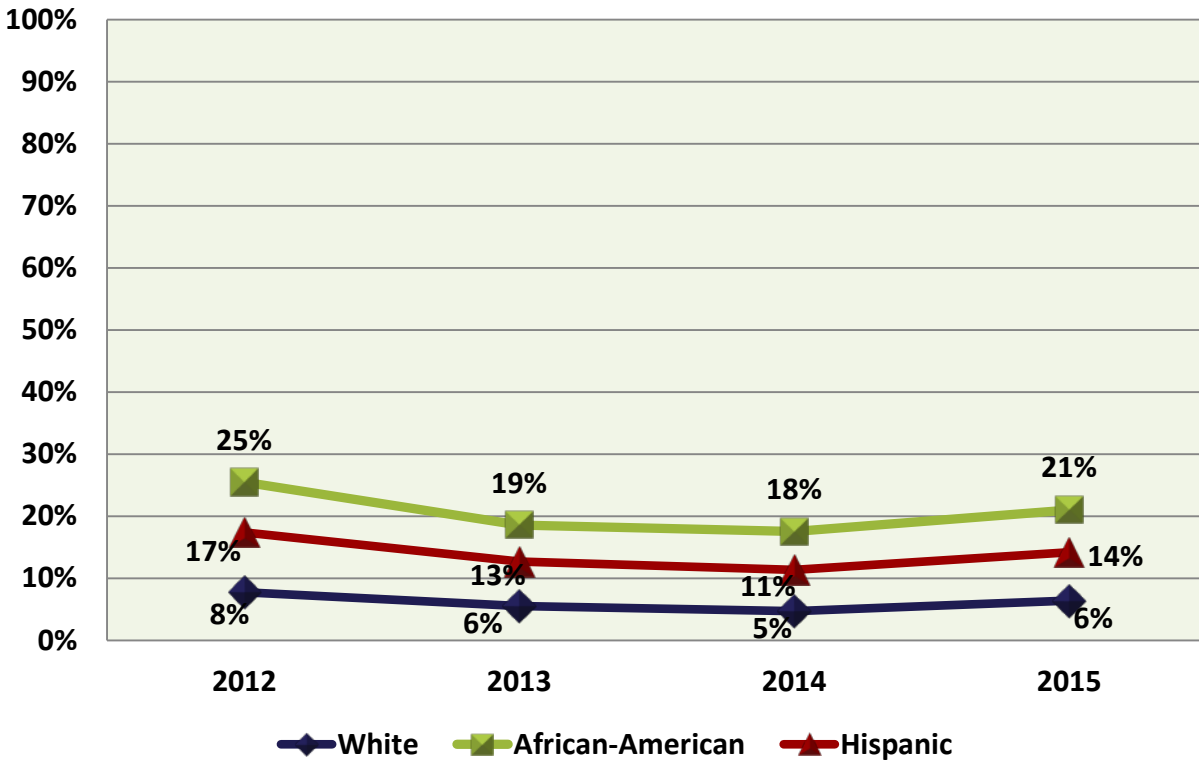


The percentage of students in grades 6-12 scoring at or above Achievement Level 4 on the Biology 1 EOC Assessment is lower by 1 percentage point for African-American and Hispanic students and 2 percentage points for White students from 2014 to 2015, and higher by 3, 8, and 7 percentage points, respectively, from 2012 to 2015.

In 2015, 37 percent of White students in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 39 percent in 2014, equal to 37 percent in 2013 and an increase from 30 percent in 2012. In 2015, 12 percent of African-American students in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 13 percent in 2014, equal to 12 percent in 2013 and an increase from 9 percent in 2012. In 2015, 25 percent of Hispanic students in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 26 percent in 2014 and an increase from 23 percent in 2013 and 17 percent in 2012.

## Grades 6-12 Biology 1 EOC Assessment Achievement Level 1



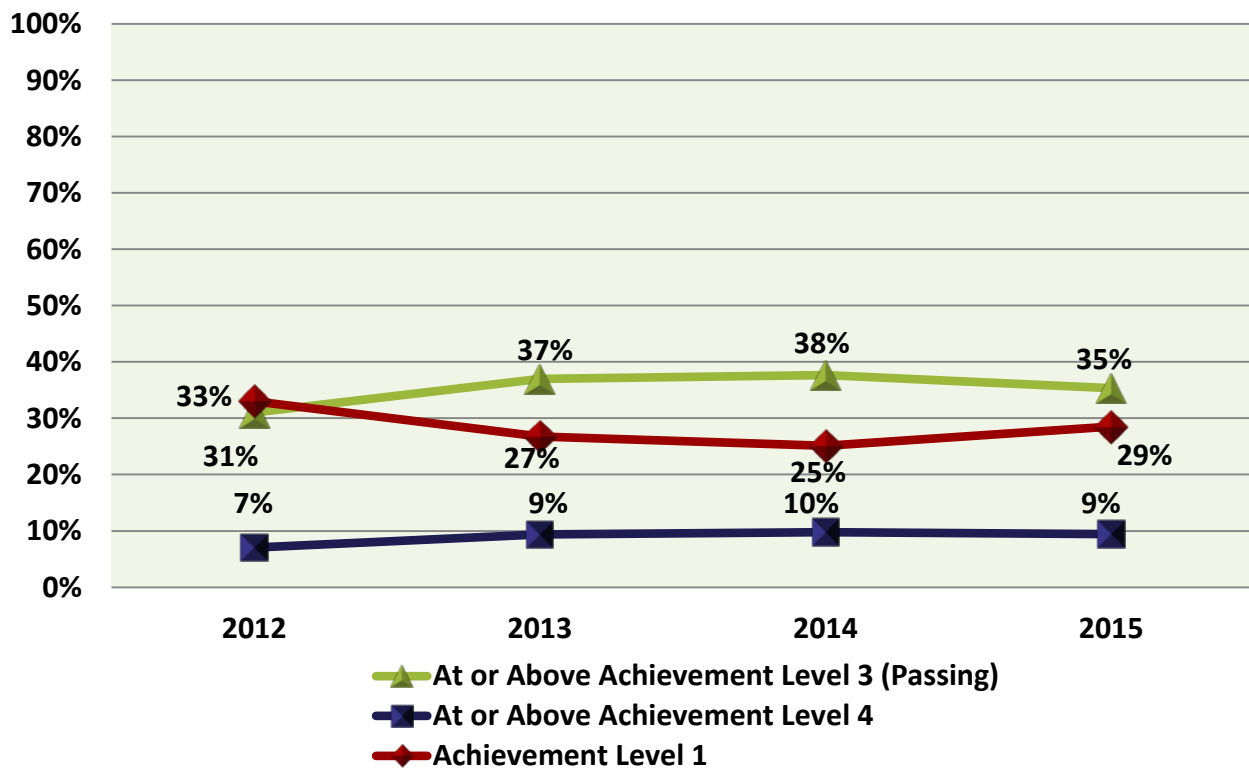
From 2012 to 2015, grades 6-12 performance on the Biology 1 EOC Assessment improved by 4 percentage points for African-American students, 3 percentage points for Hispanic students and 2 percentage points for White students.

In 2015, 6 percent of White students in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 5 percent in 2014, consistent with 6 percent in 2013 and a decrease from 8 percent in 2012. In 2015, 21 percent of African-American students in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 18 percent in 2014 and 19 percent in 2013 and a decrease from 25 percent in 2012. In 2015, 14 percent of Hispanic students in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 11 percent in 2014 and 13 percent in 2013 and a decrease from 17 percent in 2012.

## Grades 6-12 Biology 1 EOC Assessment By Achievement Level Students with Disabilities

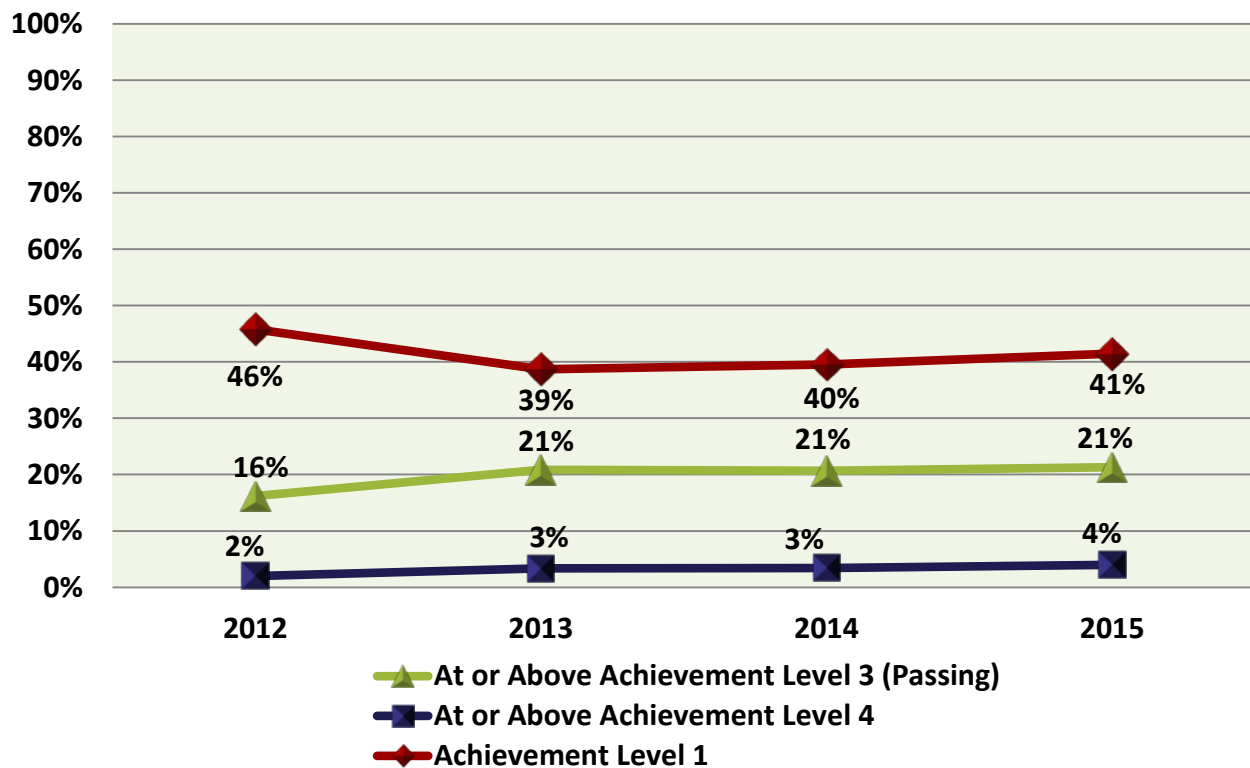


The percentage of Students with Disabilities in grades 6-12 scoring at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment is 4 percentage points higher than in 2012; however, from 2014 to 2015, performance decreased 3 percentage points.

In 2015, 35 percent of Students with Disabilities in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 38 percent in 2014 and 37 percent in 2013 and an increase from 31 percent in 2012. In 2015, 9 percent of Students with Disabilities in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 10 percent in 2014, equal to 9 percent in 2013 and an increase from 7 percent in 2012. In 2015, 29 percent of Students with Disabilities in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 25 percent in 2014 and 27 percent in 2013 and a decrease from 33 percent in 2012.

## Grades 6-12 Biology 1 EOC Assessment By Achievement Level English Language Learners

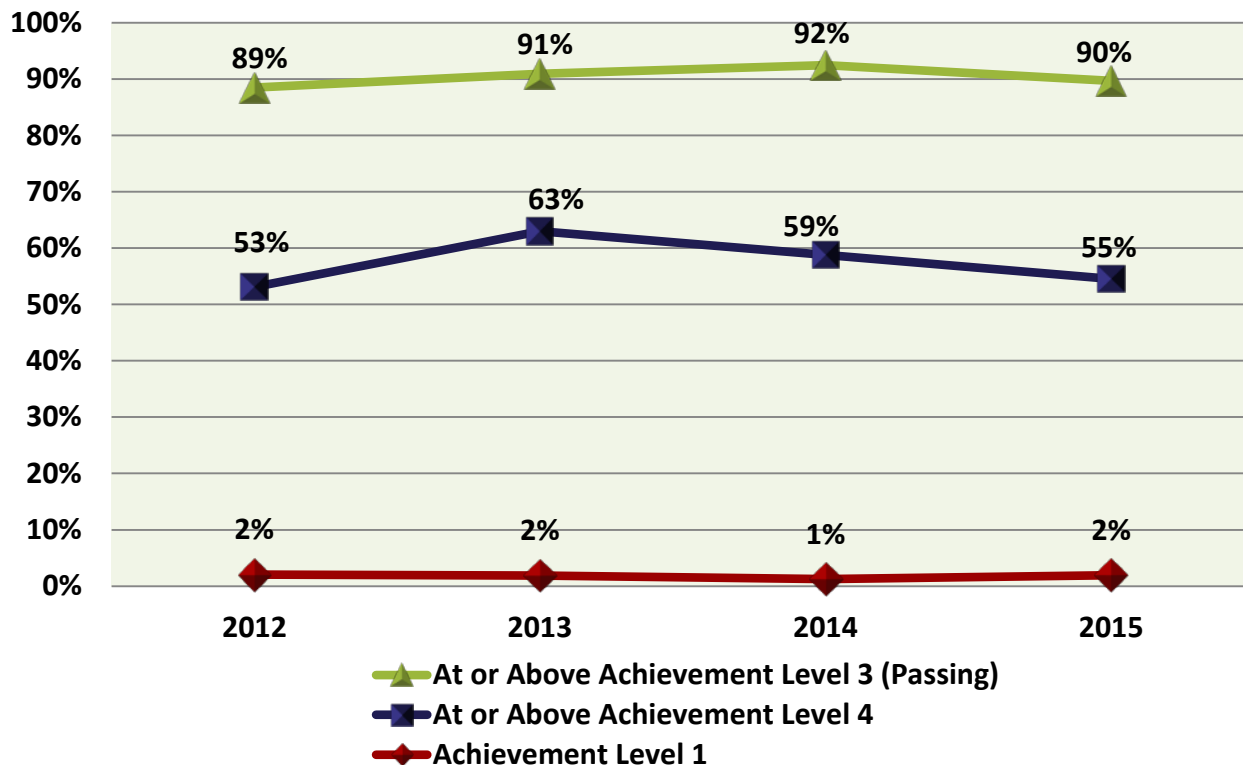


The percentage of grades 6-12 English Language Learners scoring at or above Achievement Level 4 increased 1 percentage point from 2014 to 2015 for a total of 2 percentage points since 2012. Performance at Achievement Level 3 or above (Passing) has been consistent since 2013 and is 5 percentage points higher than in 2012.

In 2015, 21 percent of English Language Learners in grades 6-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is equal to 21 percent in 2014 and 2013 and an increase from 16 percent in 2012. In 2015, 4 percent of English Language Learners in grades 6-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is an increase from 3 percent in 2014 and 2013 and 2 percent in 2012. In 2015, 41 percent of English Language Learners in grades 6-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 40 percent in 2014, 39 percent in 2013 and a decrease from 46 percent in 2012.

## Grades 6, 7 and 8 Biology 1 EOC Assessment By Achievement Level

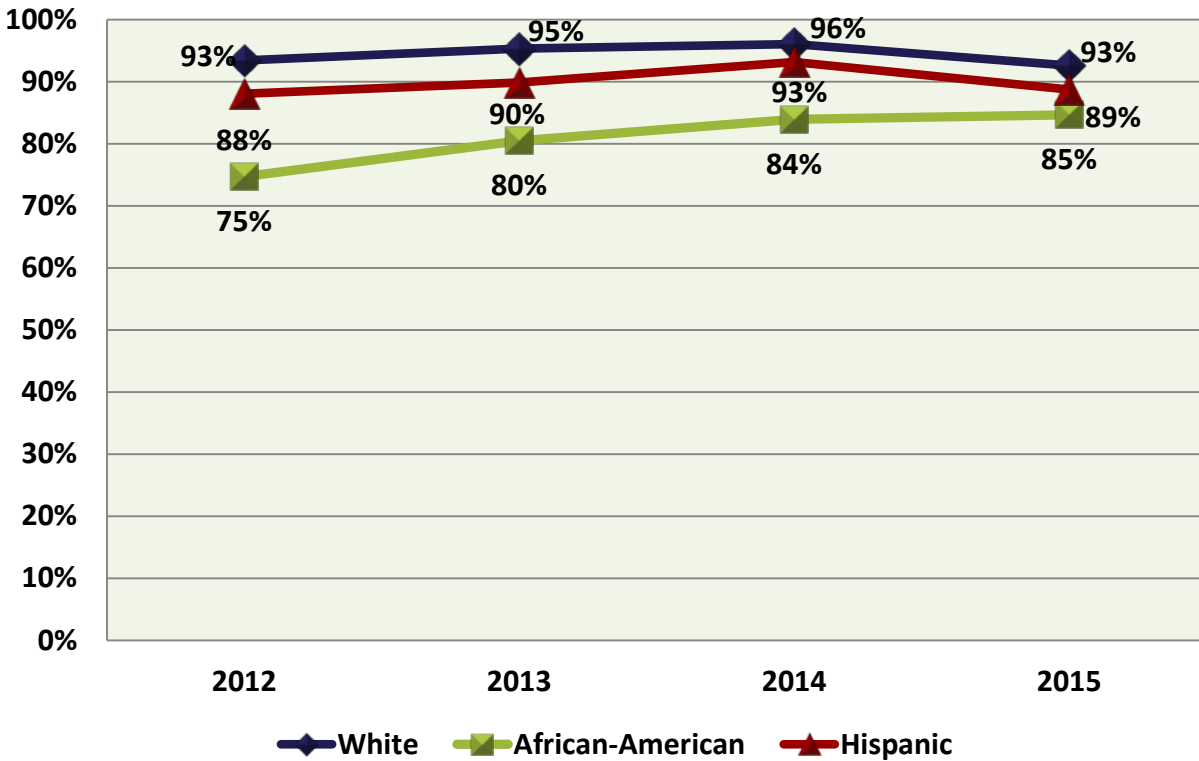


Although performance decreased 2 percentage points from 2014 to 2015, middle grades students continue to have a high percentage of students passing the Biology 1 EOC Assessment (90 percent), which is a 1 percent increase from 2012.

In 2015, 90 percent of students in grades 6, 7 and 8 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 92 percent in 2014 and 91 percent in 2013 and an increase from 89 percent in 2012. In 2015, 55 percent of students in grades 6, 7 and 8 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 59 percent in 2014 and 63 percent in 2013 and an increase from 53 percent in 2012. In 2015, 2 percent of students in grades 6, 7 and 8 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 1 percent in 2014 and equal to 2 percent in 2013 and 2012.

## Grades 6, 7 and 8 Biology 1 EOC Assessment At or Above Achievement Level 3 (Passing)

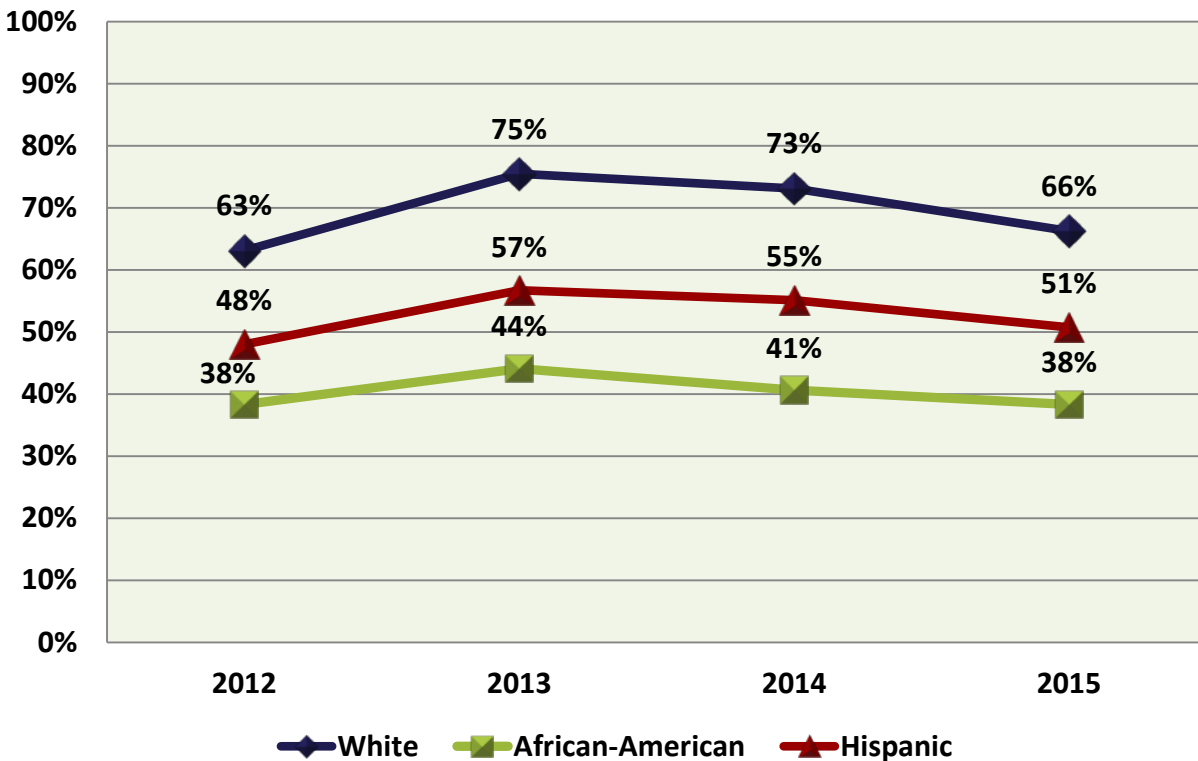


In Biology 1, African-American performance at or above Achievement Level 3 (Passing) in the middle grades increased 1 percentage point from 2014 to 2015 for a total increase of 10 percentage points since 2012. The performance of White and Hispanic students in grades 6, 7 and 8 decreased this year.

In 2015, 93 percent of White students in grades 6, 7 and 8 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 96 percent in 2014 and 95 percent in 2013 and equal to 93 percent in 2012. In 2015, 85 percent of African-American students in grades 6, 7 and 8 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is an increase from 84 percent in 2014, 80 percent in 2013 and 75 percent in 2012. In 2015, 89 percent of Hispanic students in grades 6, 7 and 8 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 93 percent in 2014 and 90 percent in 2013 and an increase from 88 percent in 2012.

## Grades 6, 7 and 8 Biology 1 EOC Assessment At or Above Achievement Level 4

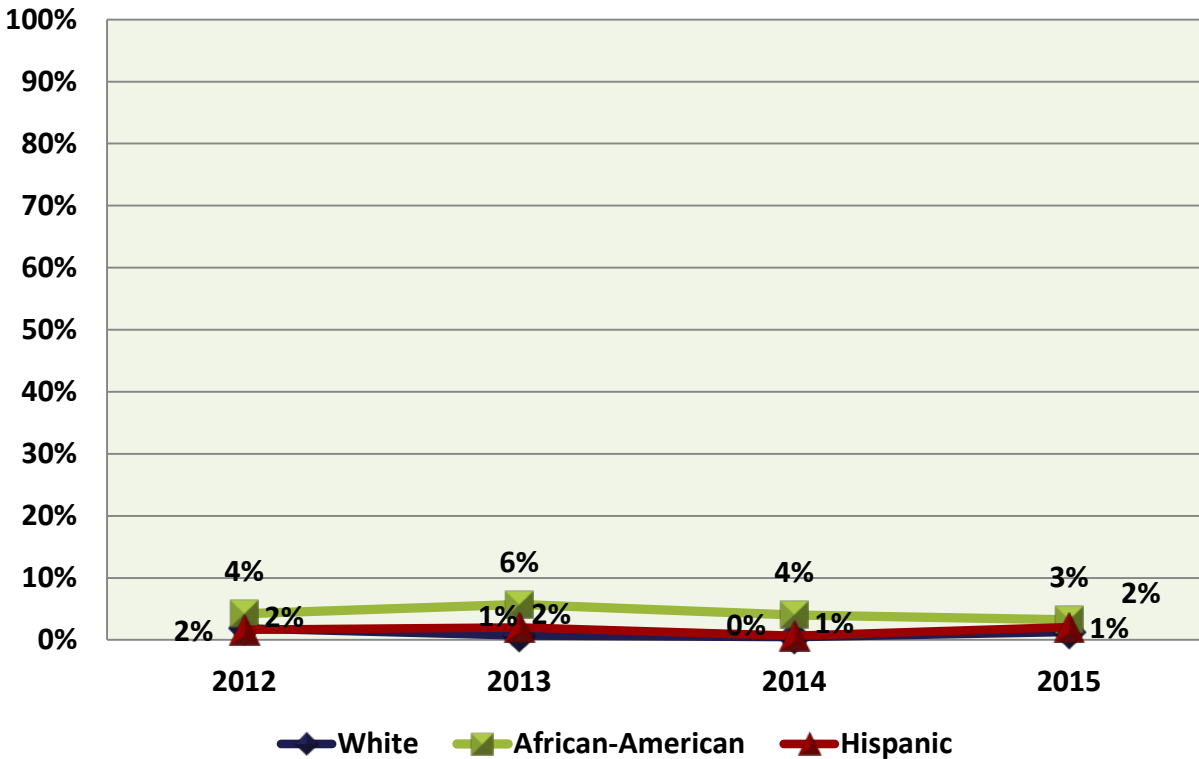


Middle grades' performance at or above Achievement Level 4 on the Biology 1 EOC Assessment decreased for White, African-American and Hispanic students from 2014 to 2015 by 7, 3 and 4 percentage points, respectively.

In 2015, 66 percent of White students in grades 6, 7 and 8 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 73 percent in 2014 and 75 percent in 2013 and an increase from 63 percent in 2012. In 2015, 38 percent of African-American students in grades 6, 7 and 8 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 41 percent in 2014 and 44 percent in 2013 and equal to 38 percent in 2012. In 2015, 51 percent of Hispanic students in grades 6, 7 and 8 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 55 percent in 2014 and 57 percent in 2013 and an increase from 48 percent in 2012.

## Grades 6, 7 and 8 Biology 1 EOC Assessment Achievement Level 1

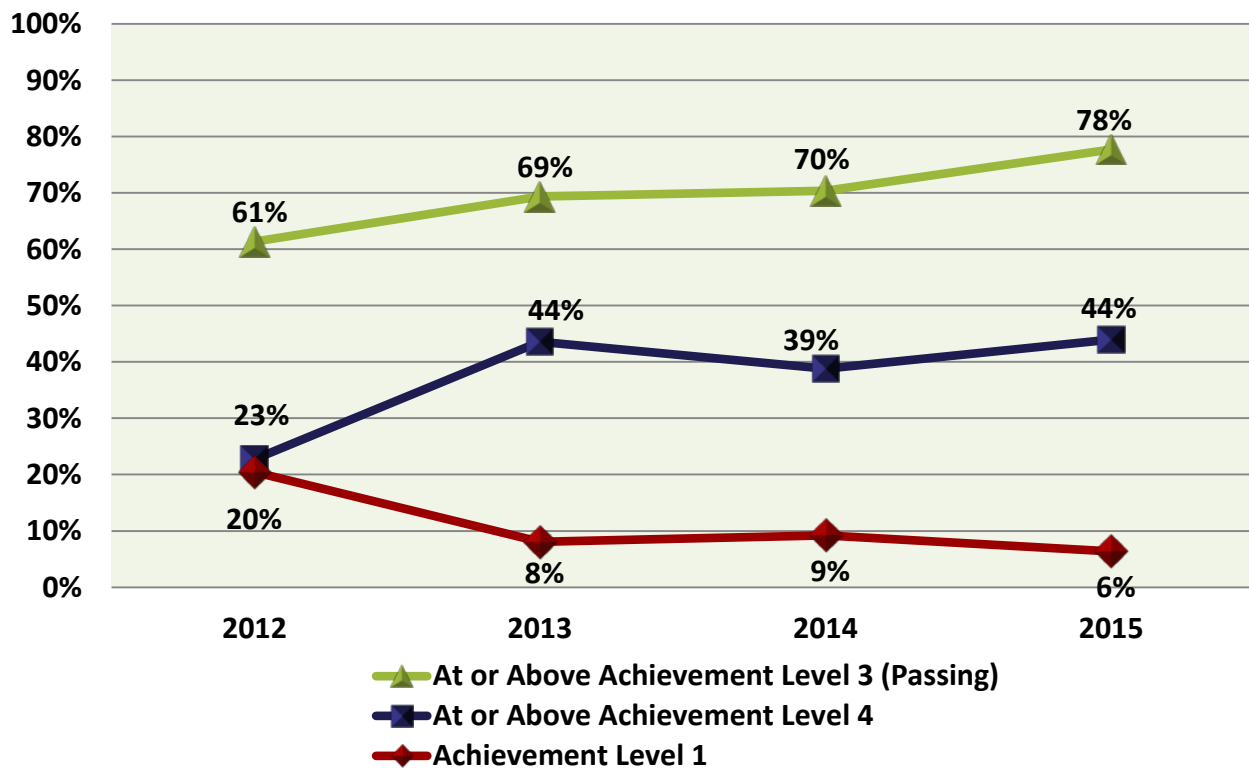


In Biology 1, the percentage of African-American students in grades 6, 7 and 8 performing at Achievement Level 1 decreased (improved) from 2014 to 2015 by 1 percentage point, and the percentage of White and Hispanic students increased 1 percentage point.

In 2015, 1 percent of White students in grades 6, 7 and 8 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 0 percent in 2014, equal to 1 percent in 2013 and a decrease from 2 percent in 2012. In 2015, 3 percent of African-American students in grades 6, 7 and 8 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is a decrease from 4 percent in 2014, 6 percent in 2013 and 4 percent in 2012. In 2015, 2 percent of Hispanic students in grades 6, 7 and 8 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 1 percent in 2014 and consistent with 2 percent in 2013 and 2012.

## Grades 6, 7 and 8 Biology 1 EOC Assessment By Achievement Level Students with Disabilities

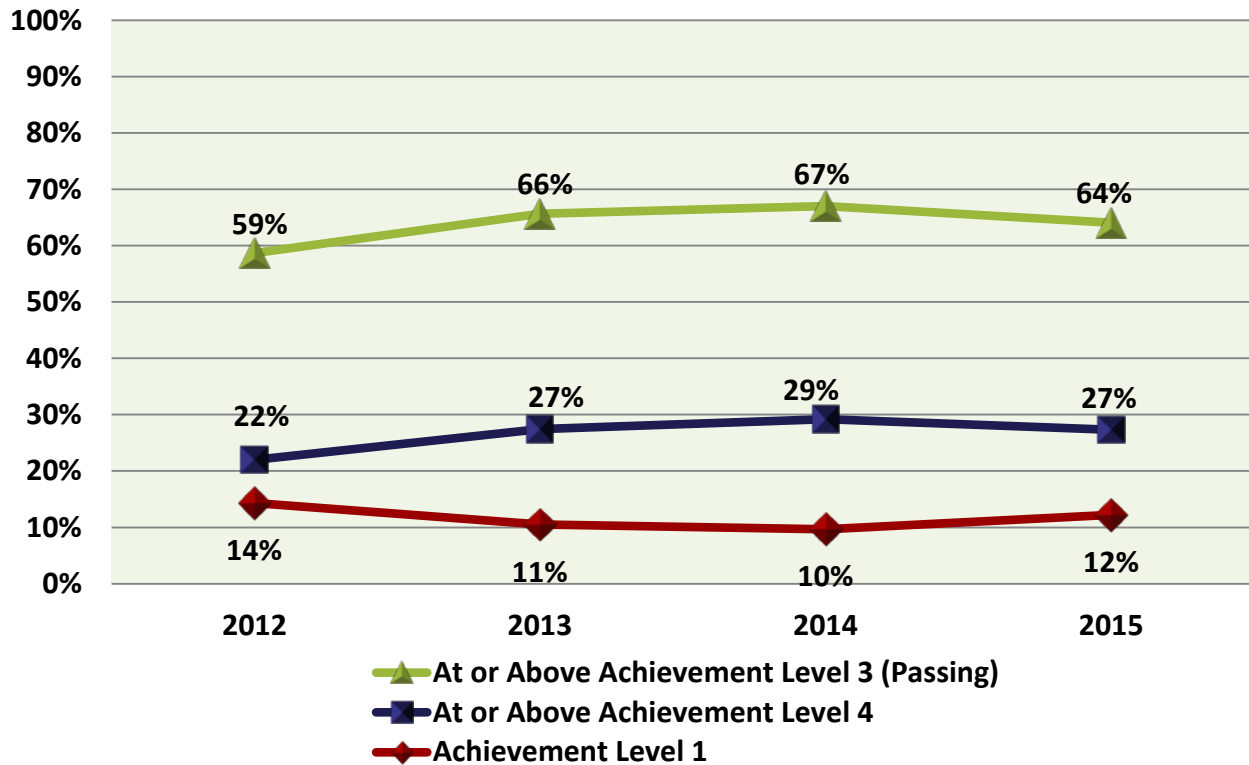


In Biology 1, the percentage of Students with Disabilities in grades 6, 7 and 8 scoring at or above Achievement Level 3 (Passing) increased by 8 percentage points from 2014 to 2015, for a total of 17 percentage points since 2012. Performance increased this year by 5 percentage points at or above Achievement Level 4, for a total of 21 percentage points since 2012.

In 2015, 78 percent of Students with Disabilities in grades 6, 7 and 8 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is an increase from 70 percent in 2014, 69 percent in 2013 and 61 percent in 2012. In 2015, 44 percent of Students with Disabilities in grades 6, 7 and 8 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is an increase from 39 percent in 2014, equal to 44 percent in 2013 and an increase from 23 percent in 2012. In 2015, 6 percent of Students with Disabilities in grades 6, 7 and 8 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is a decrease from 9 percent in 2014, 8 percent in 2013 and 20 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment By Achievement Level



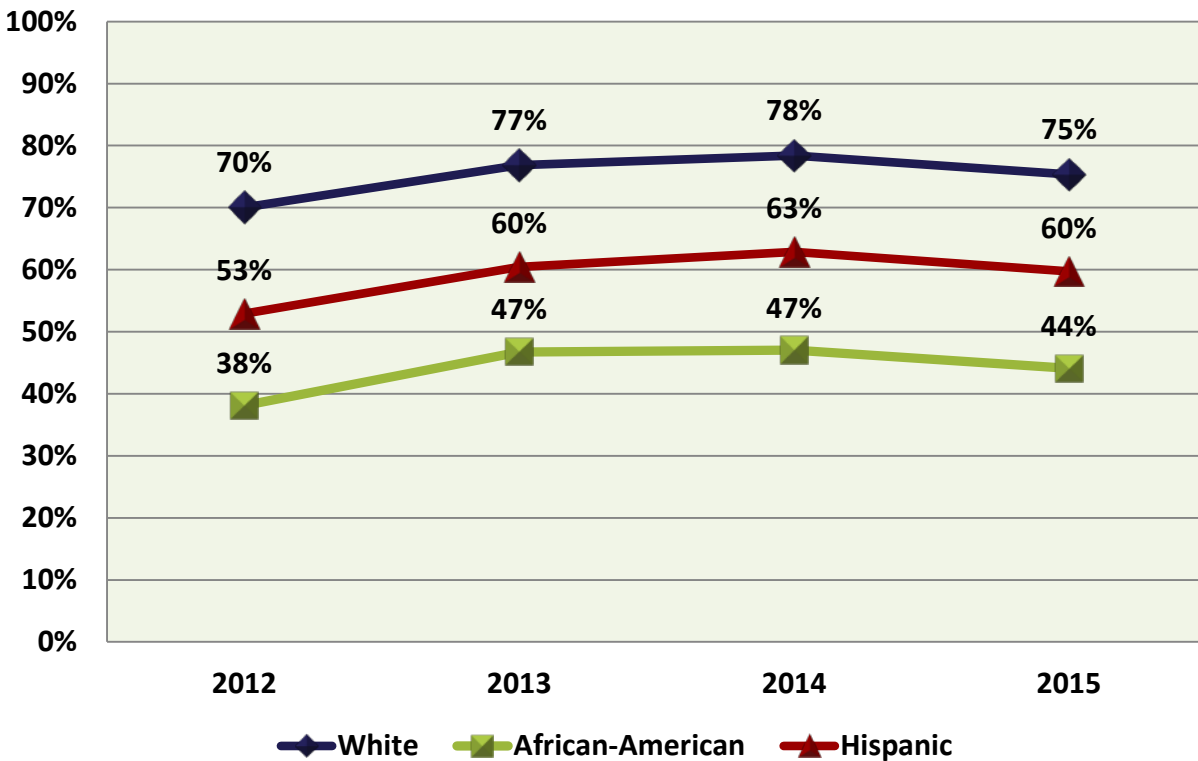
Compared to 2012, performance on the Biology 1 EOC Assessment in grades 9-12 is higher by 5 percentage points at or above Achievement Level 3 (Passing) and at or above Achievement Level 4, but performance decreased by 3 and 2 percentage points, respectively, since 2014.

In 2015, 64 percent of students in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 67 percent in 2014 and 66 percent in 2013 and an increase from 59 percent in 2012. In 2015, 27 percent of students in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 29 percent in 2014, equal to 27 percent in 2013 and an increase from 22 percent in 2012. In 2015, 12 percent of students in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 10 percent in 2014 and 11 percent in 2013 and a decrease from 14 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment At or Above Achievement Level 3 (Passing)

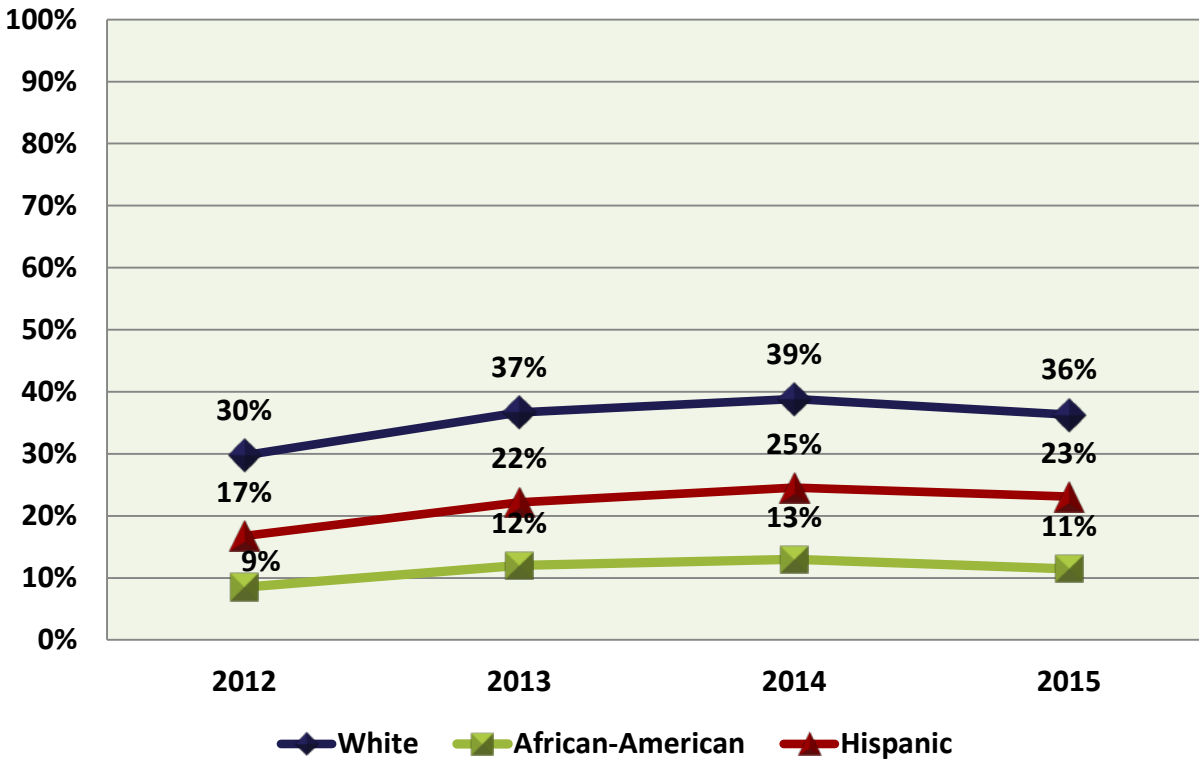


From 2014 to 2015, the percentage of White, African-American, and Hispanic students scoring at or above Achievement Level 3 (Passing) on the Biology 1 EOC assessment decreased 3 percentage points, but compared to 2012 the percentage for each subgroup is higher by 5, 6 and 7 percentage points, respectively.

In 2015, 75 percent of White students in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 78 percent in 2014 and 77 percent in 2013 and an increase from 70 percent in 2012. In 2015, 44 percent of African-American students in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 47 percent in 2014 and 2013 and an increase from 38 percent in 2012. In 2015, 60 percent of Hispanic students in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 63 percent in 2014, equal to 60 percent in 2013 and an increase from 53 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment At or Above Achievement Level 4

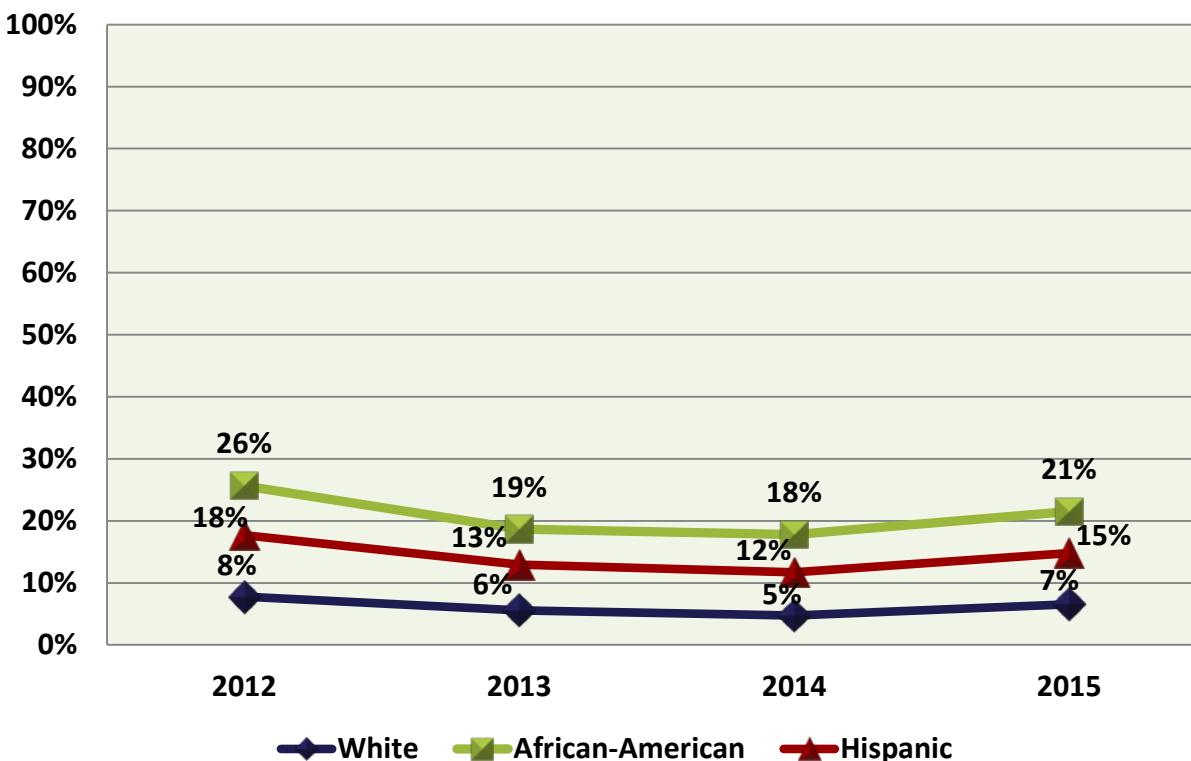


Compared to 2012, White and Hispanic students in grades 9-12 scored 6 percentage points higher and African-American students performed 2 percentage points higher on the Biology 1 EOC Assessment, which represents a 3, 2 and 2 percentage-point decrease, respectively, from 2014.

In 2015, 36 percent of White students in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 39 percent in 2014 and 37 percent in 2013 and an increase from 30 percent in 2012. In 2015, 11 percent of African-American students in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 13 percent in 2014 and 12 percent in 2013 and an increase from 9 percent in 2012. In 2015, 23 percent of Hispanic students in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 25 percent in 2014 and an increase from 22 percent in 2013 and 17 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment Achievement Level 1

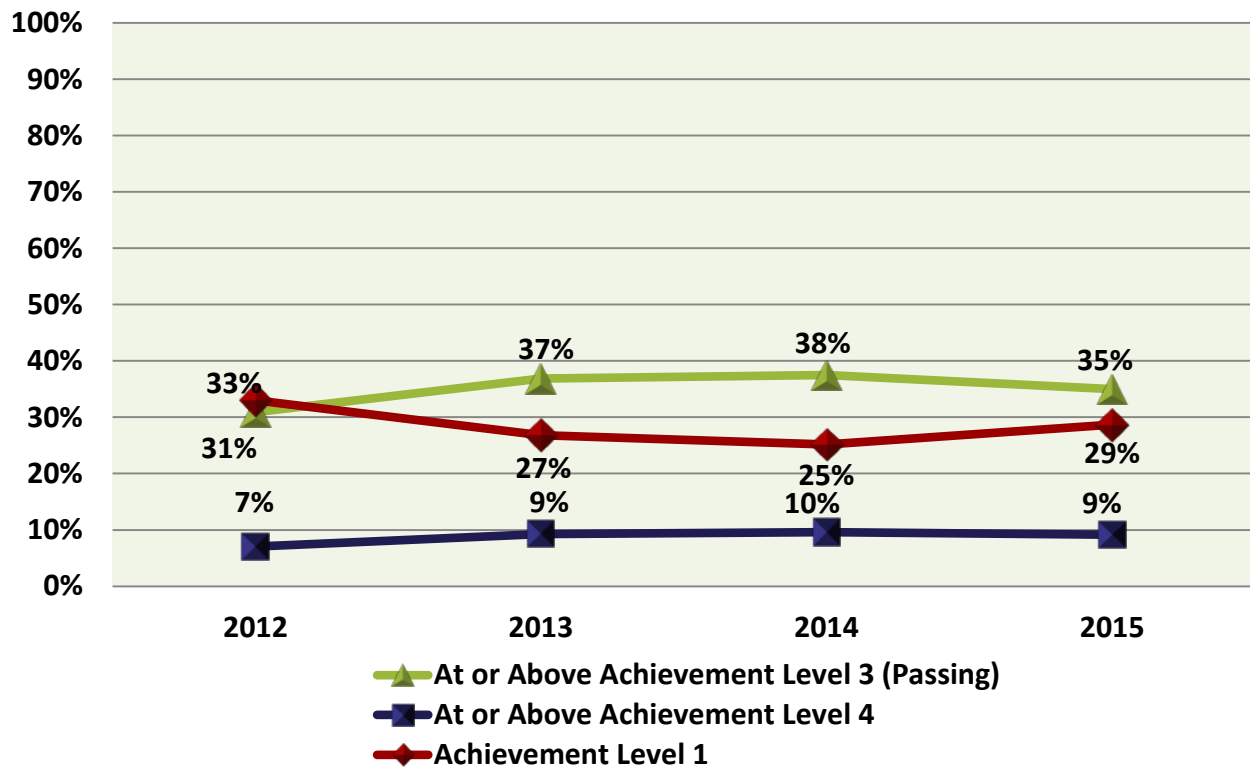


In grades 9-12, the percentage scoring at Achievement Level 1 on the Biology 1 EOC Assessment increased 2 percentage points for White students, and 3 percentage points for African-American and Hispanic students since 2014.

In 2015, 7 percent of White students in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 5 percent in 2014 and 6 percent in 2013 and a decrease from 8 percent in 2012. In 2015, 21 percent of African-American students in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 18 percent in 2014 and 19 percent in 2013 and a decrease from 26 percent in 2012. In 2015, 15 percent of Hispanic students in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 12 percent in 2014 and 13 percent in 2013 and a decrease from 18 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment By Achievement Level Students with Disabilities

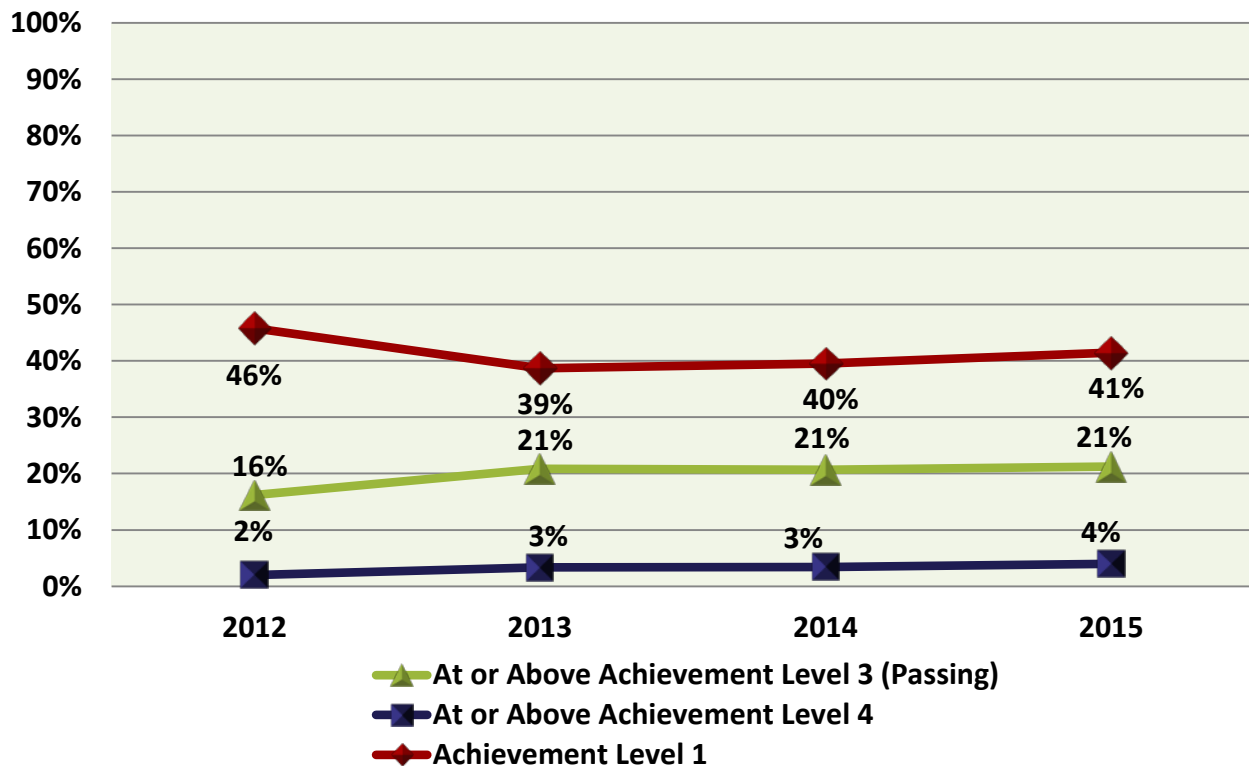


In 2015, the percentage of Students with Disabilities in grade 9-12 scoring at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment decreased 3 percentage points from 2014, which is 4 percentage points higher than in 2012.

In 2015, 35 percent of Students with Disabilities in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is a decrease from 38 percent in 2014 and 37 percent in 2013 and an increase from 31 percent in 2012. In 2015, 9 percent of Students with Disabilities in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is a decrease from 10 percent in 2014, equal to 9 percent in 2013 and an increase from 7 percent in 2012. In 2015, 29 percent of Students with Disabilities in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 25 percent in 2014 and 27 percent in 2013 and a decrease from 33 percent in 2012.

## Grades 9-12 Biology 1 EOC Assessment By Achievement Level English Language Learners



The percentage of English Language Learners in grades 9-12 scoring at or above Achievement Level 4 on the Biology 1 EOC Assessment increased 1 percentage point from 2014 to 2015, while performance at Achievement Level 3 or above remained consistent.

In 2015, 21 percent of English Language Learners in grades 9-12 performed at or above Achievement Level 3 (Passing) on the Biology 1 EOC Assessment. This is equal to 21 percent in 2014 and 2013 and an increase from 16 percent in 2012. In 2015, 4 percent of English Language Learners in grades 9-12 performed at or above Achievement Level 4 on the Biology 1 EOC Assessment. This is an increase from 3 percent in 2014 and 2013 and 2 percent in 2012. In 2015, 41 percent of English Language Learners in grades 9-12 performed at Achievement Level 1 on the Biology 1 EOC Assessment. This is an increase from 40 percent in 2014, 39 percent in 2013 and a decrease from 46 percent in 2012.

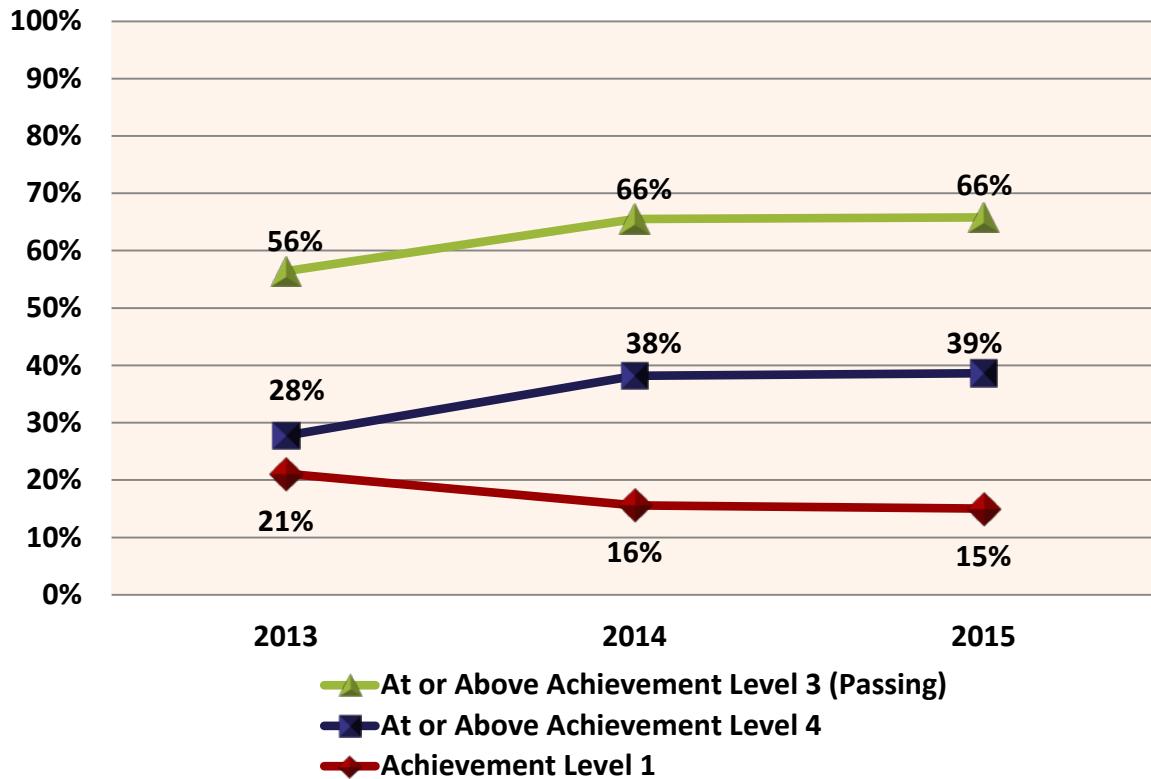

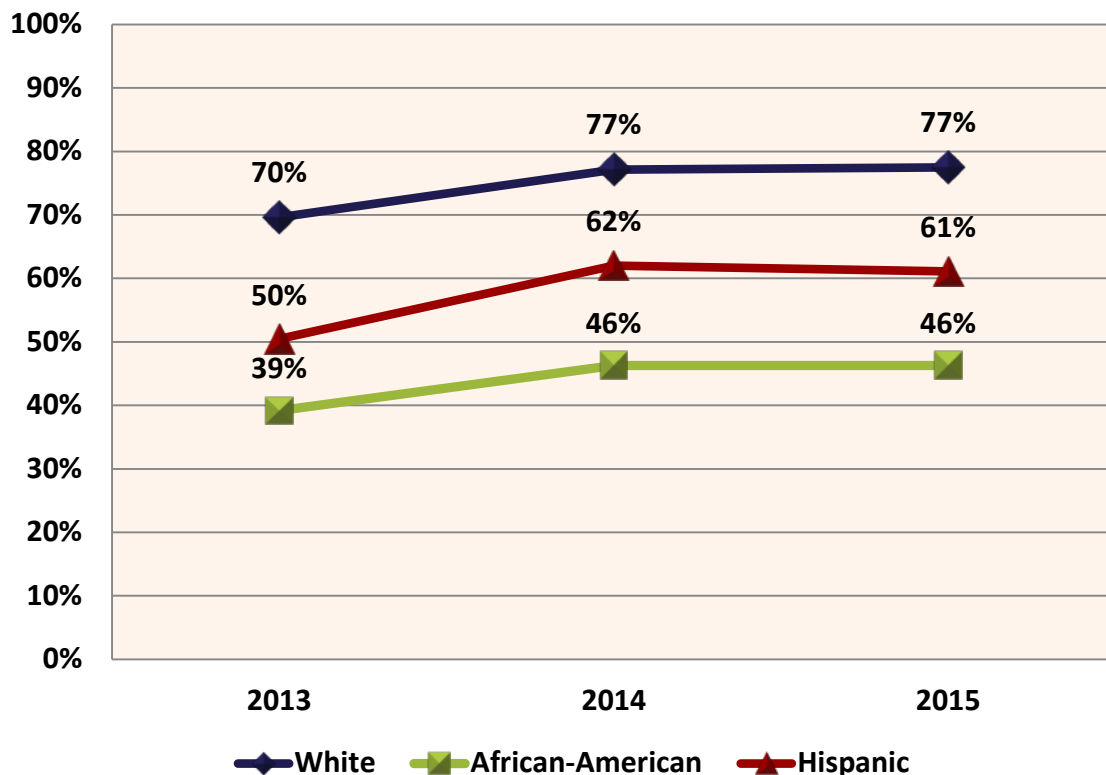

Since 2013, this represents a 10-point increase at or Above Achievement Level 3 (Passing), an 11-point increase at or above Achievement Level 4, and a 6-point decrease at Achievement Level 1.

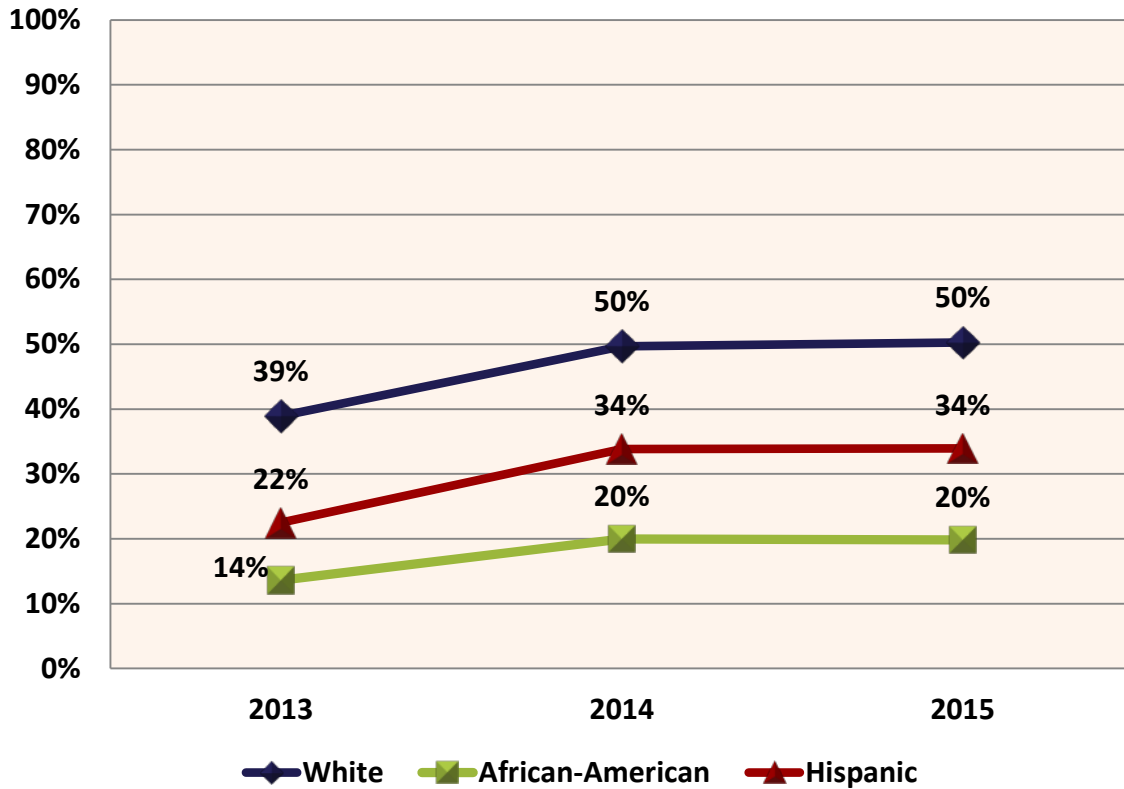

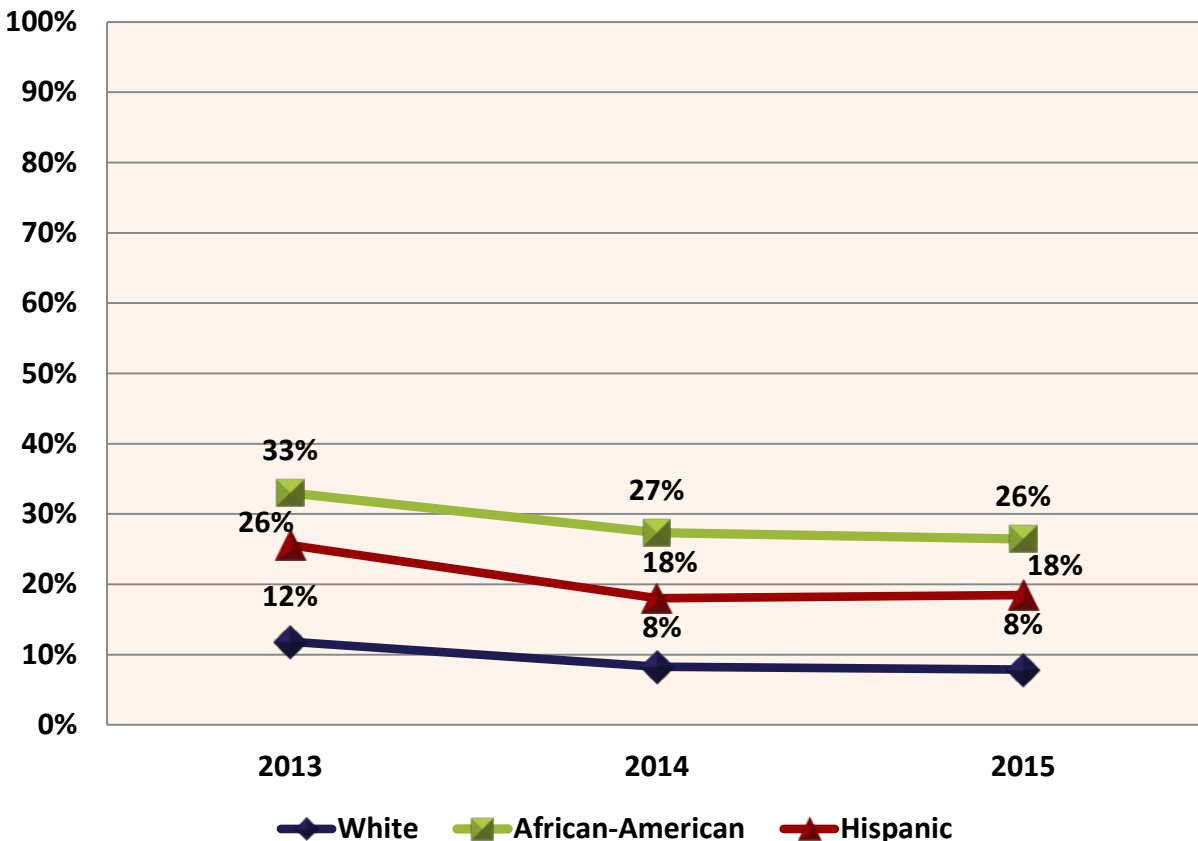

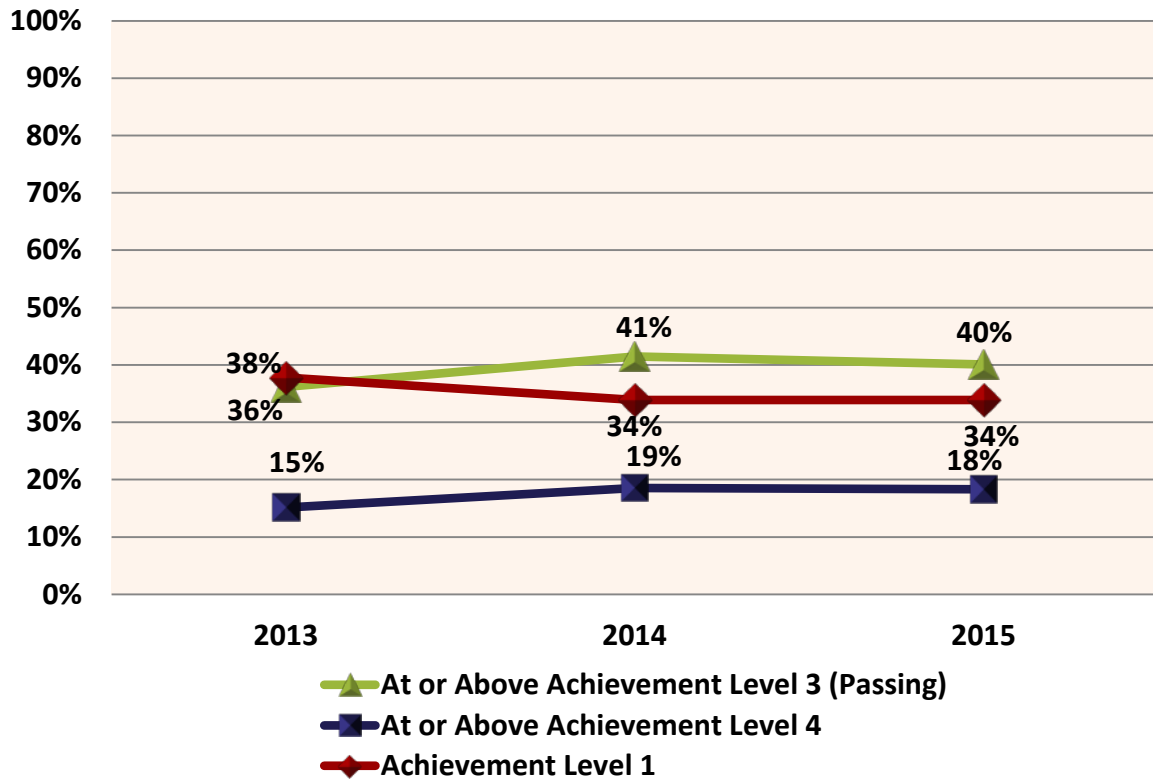

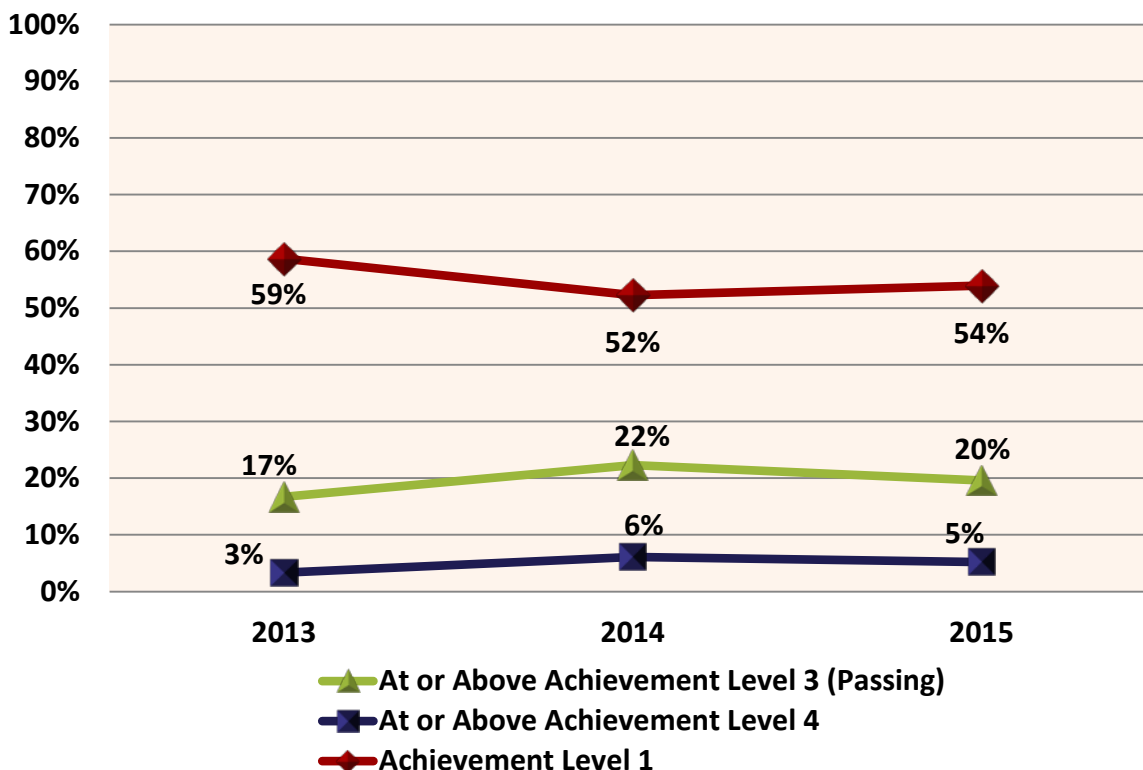

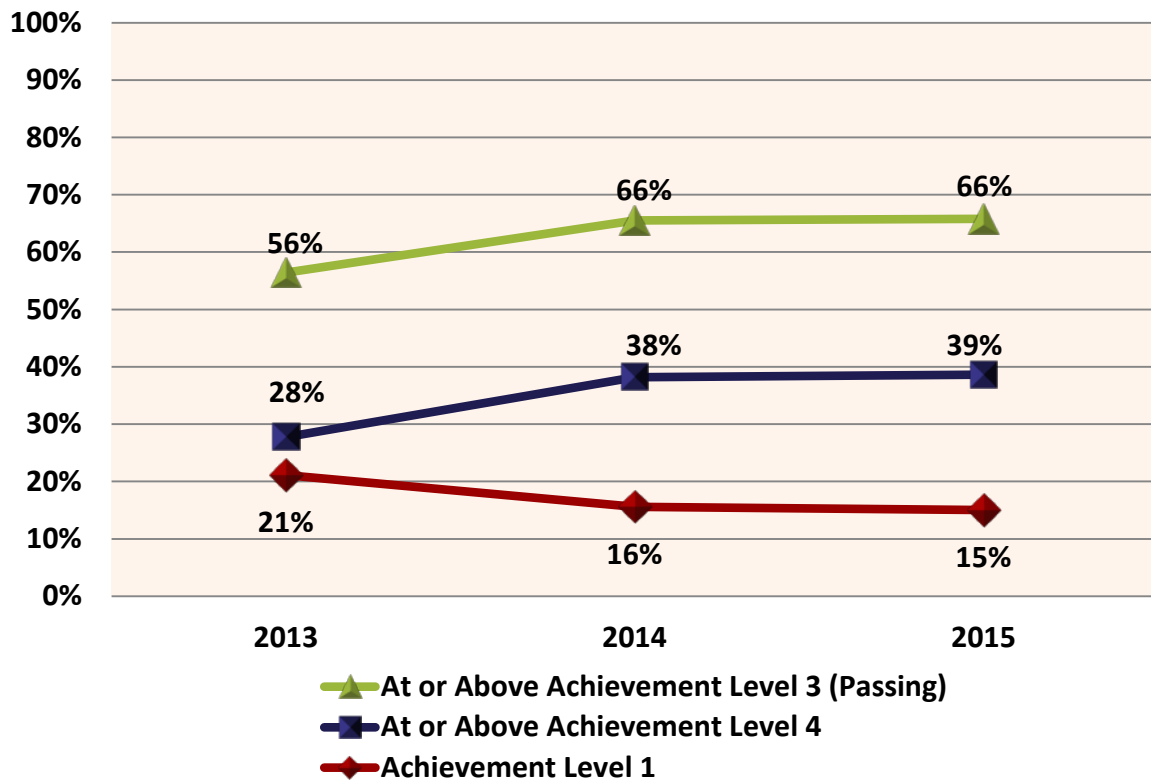

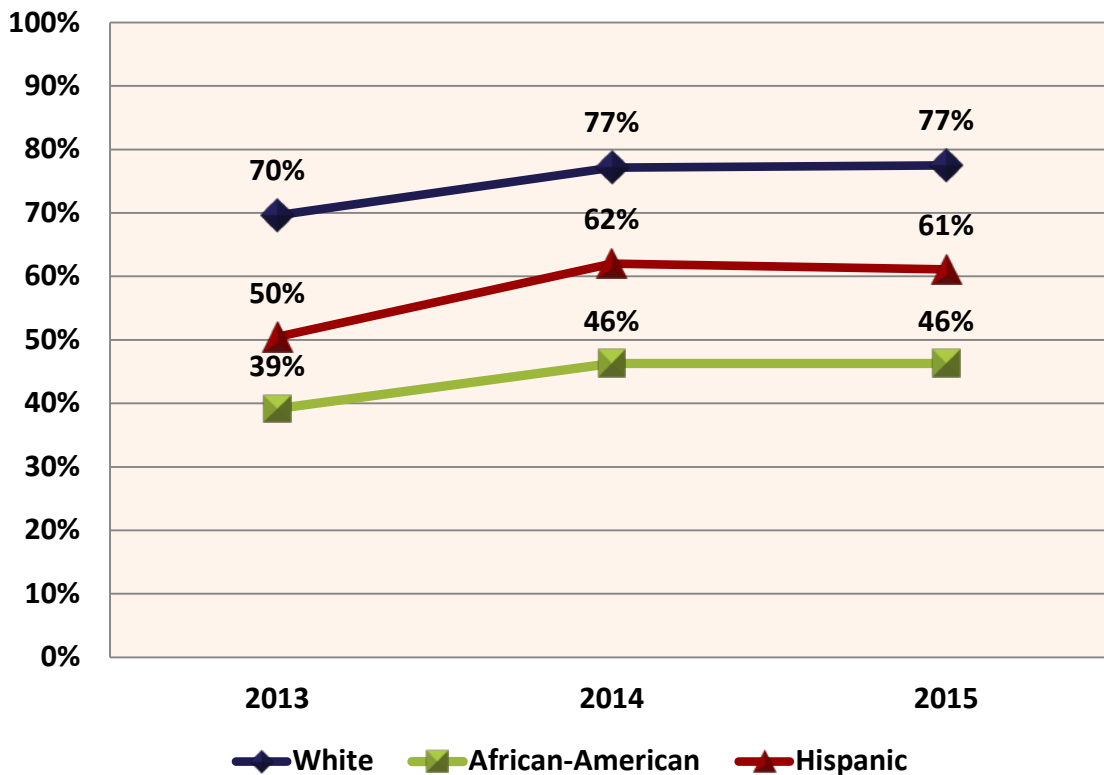

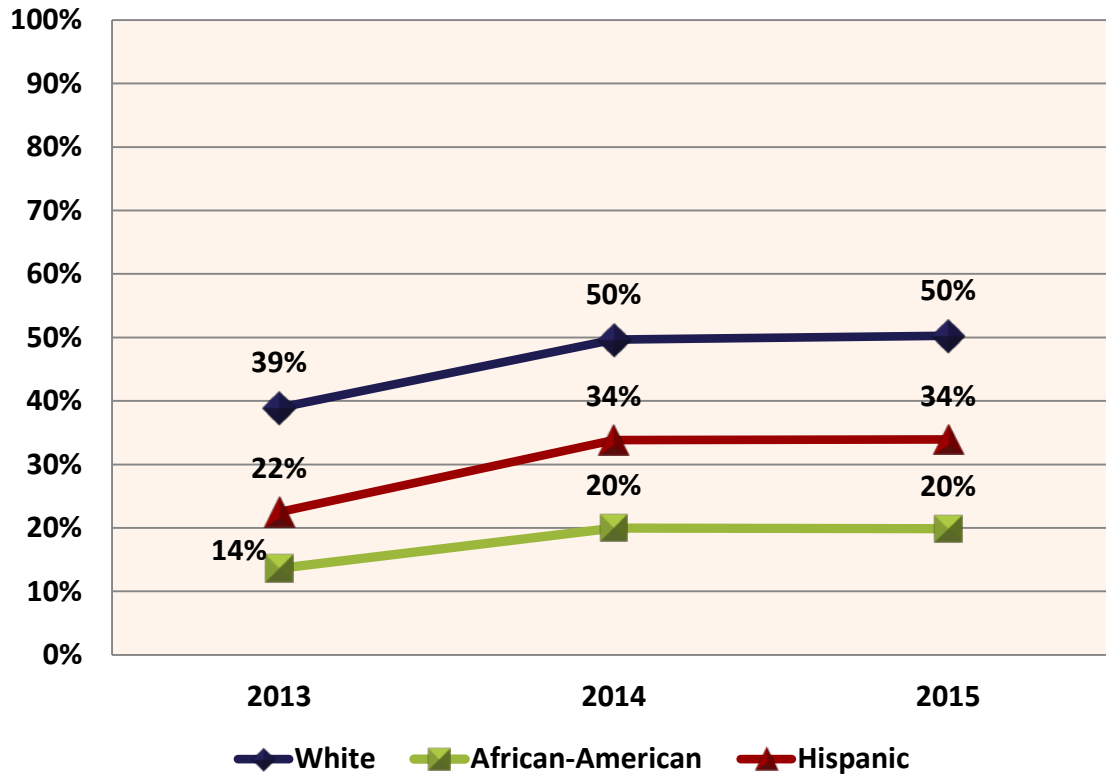

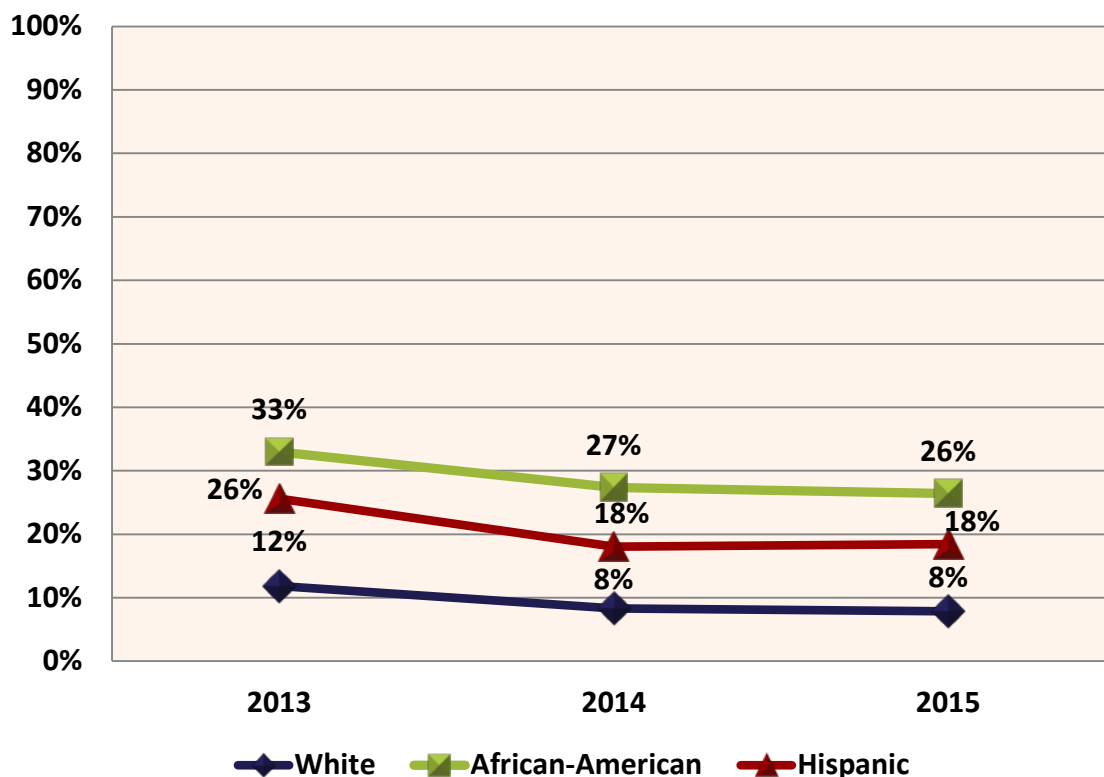

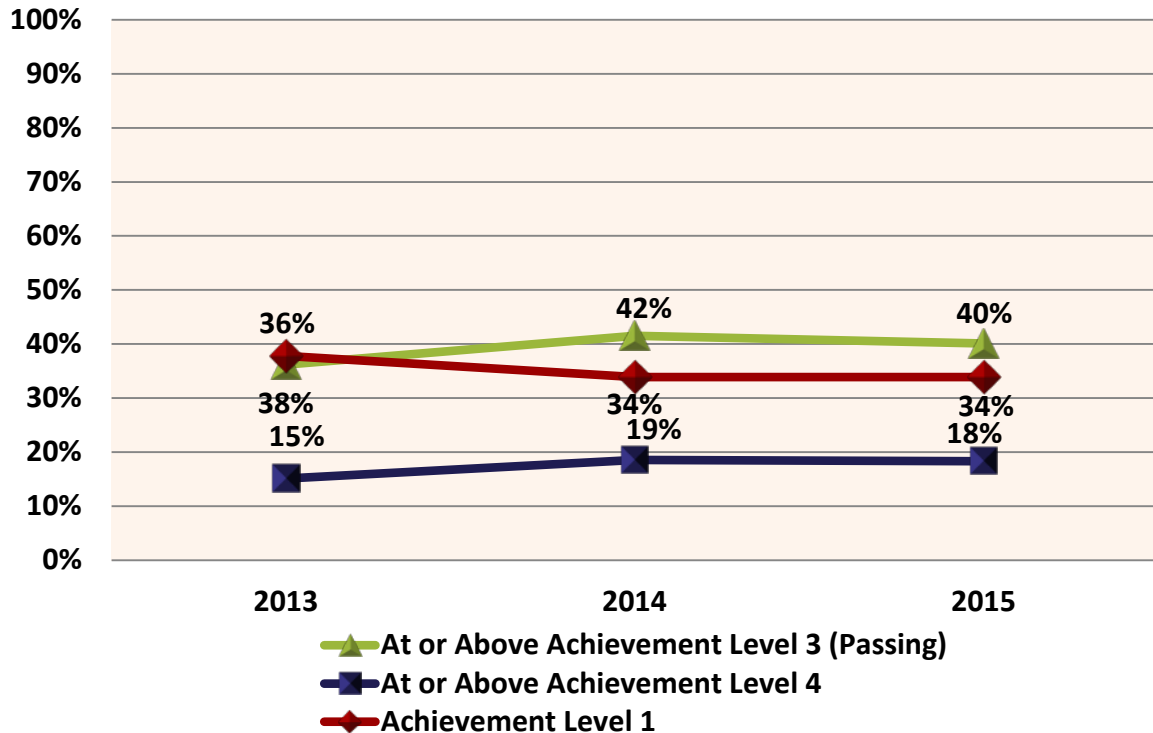

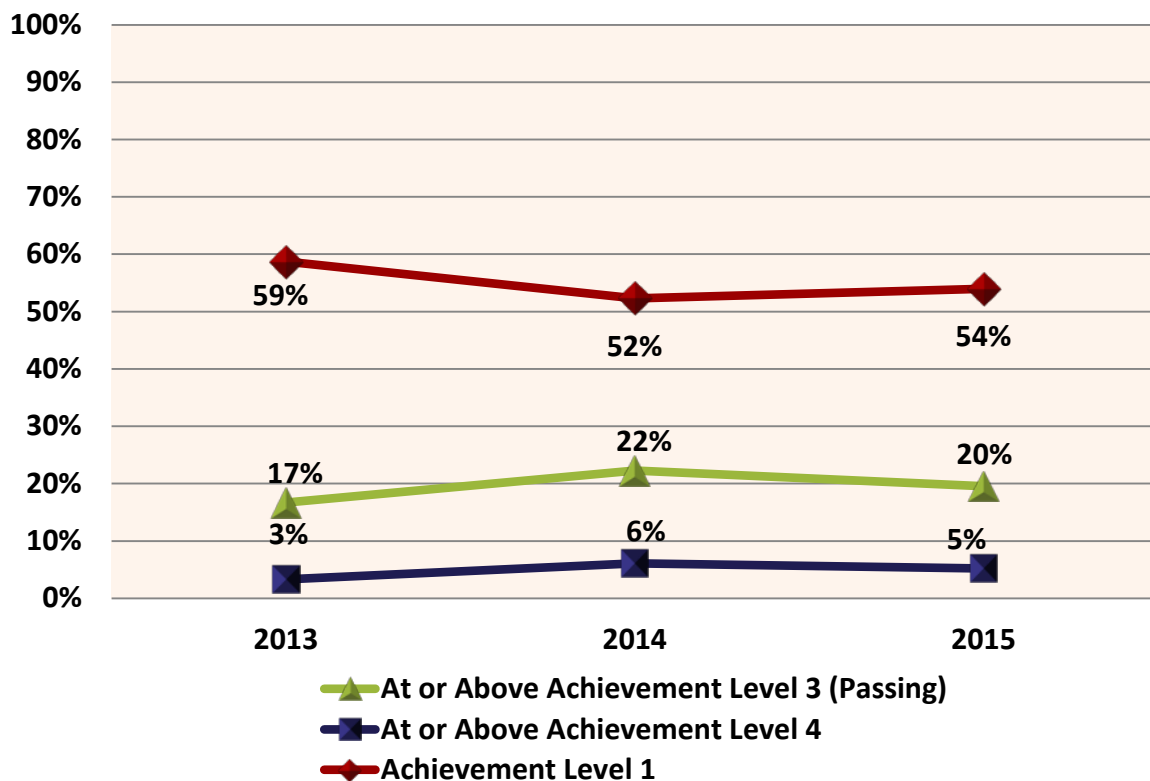

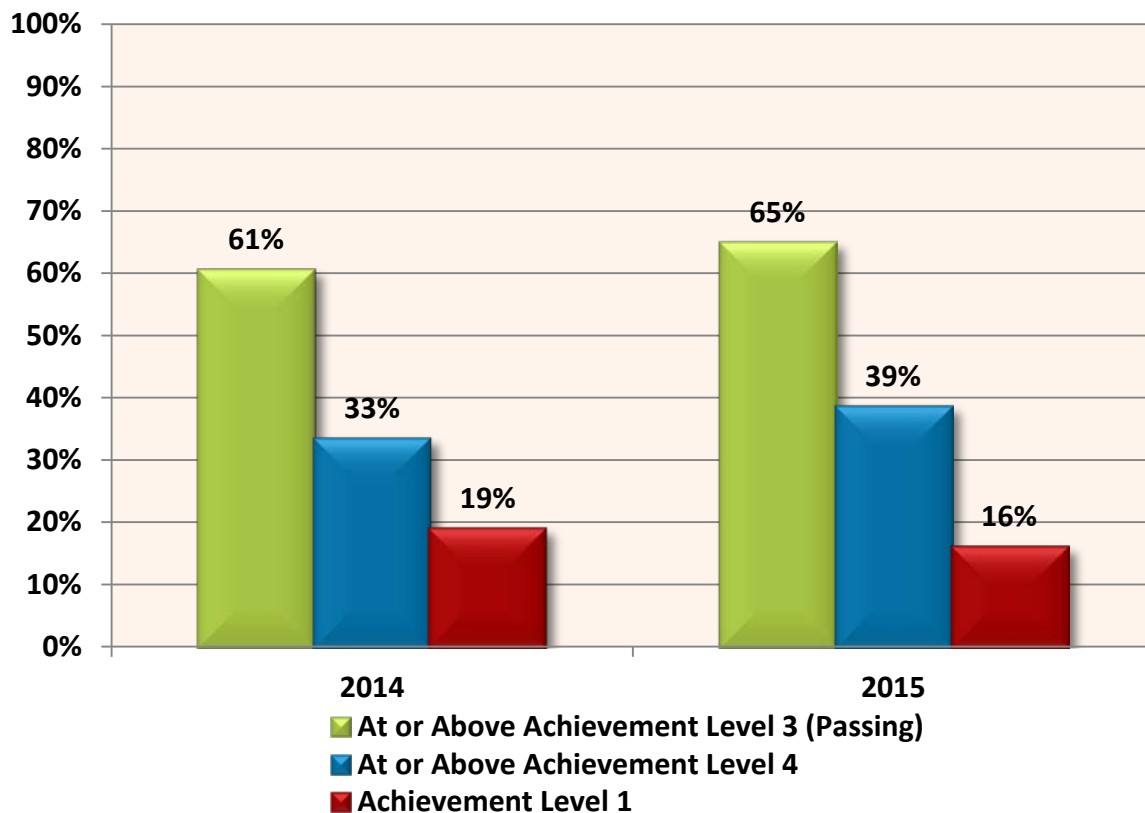

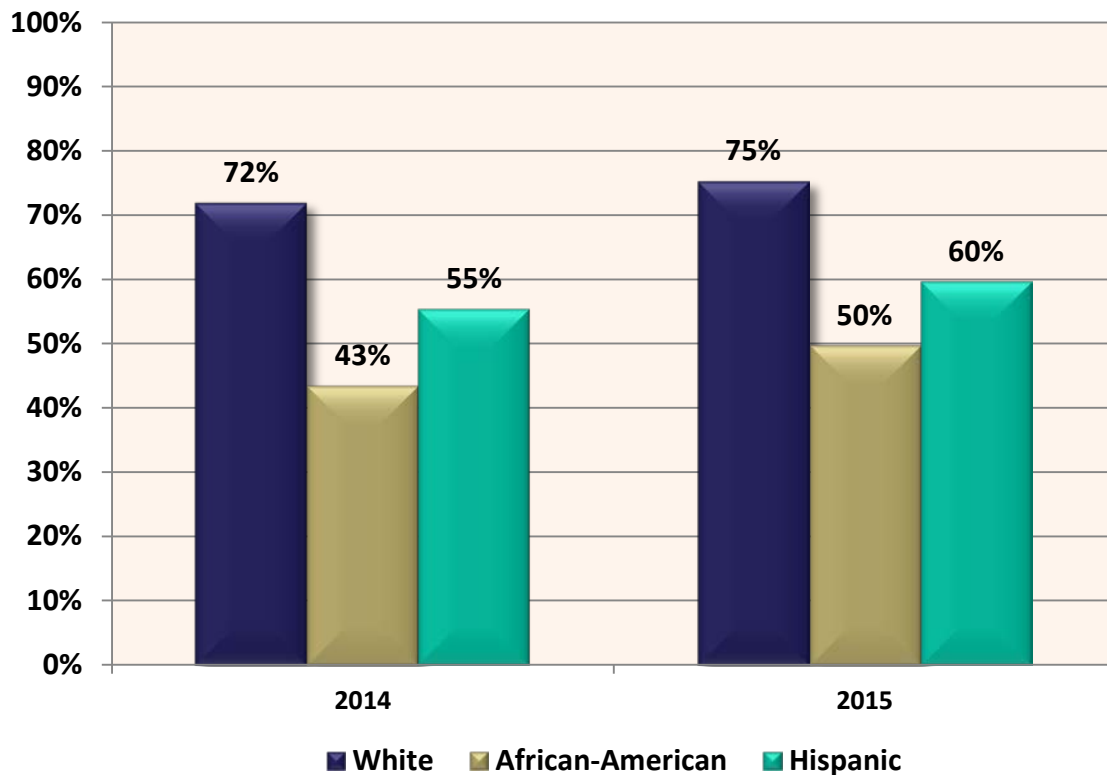

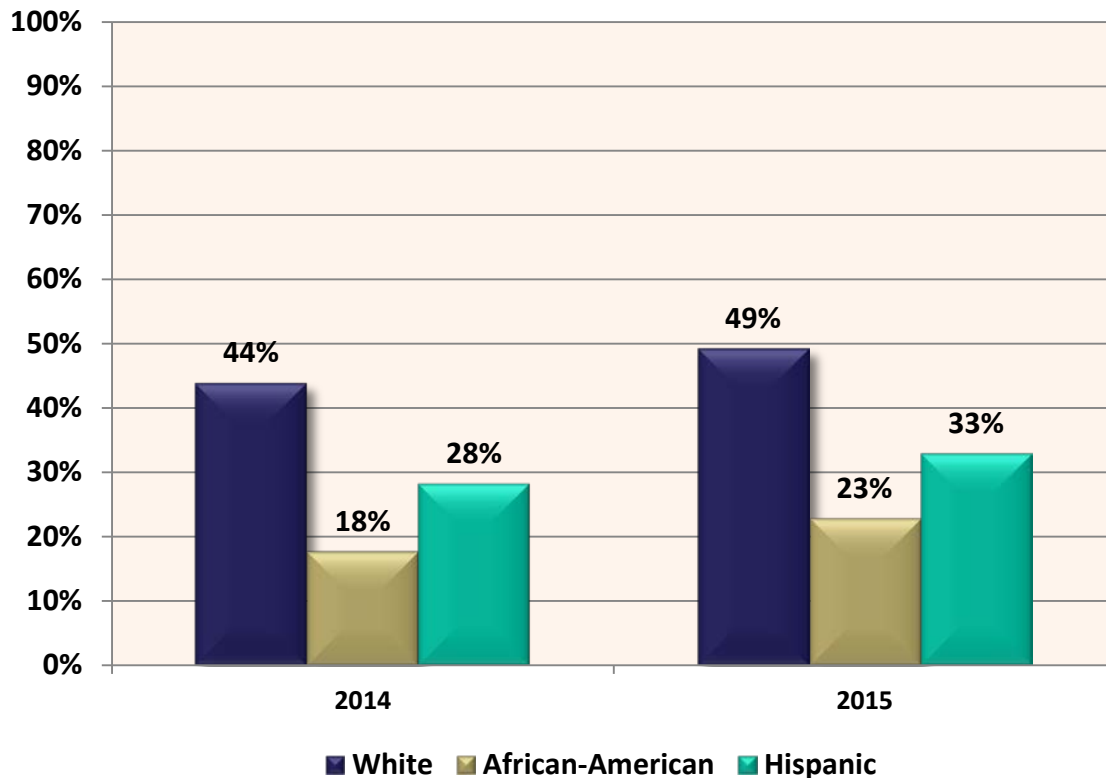

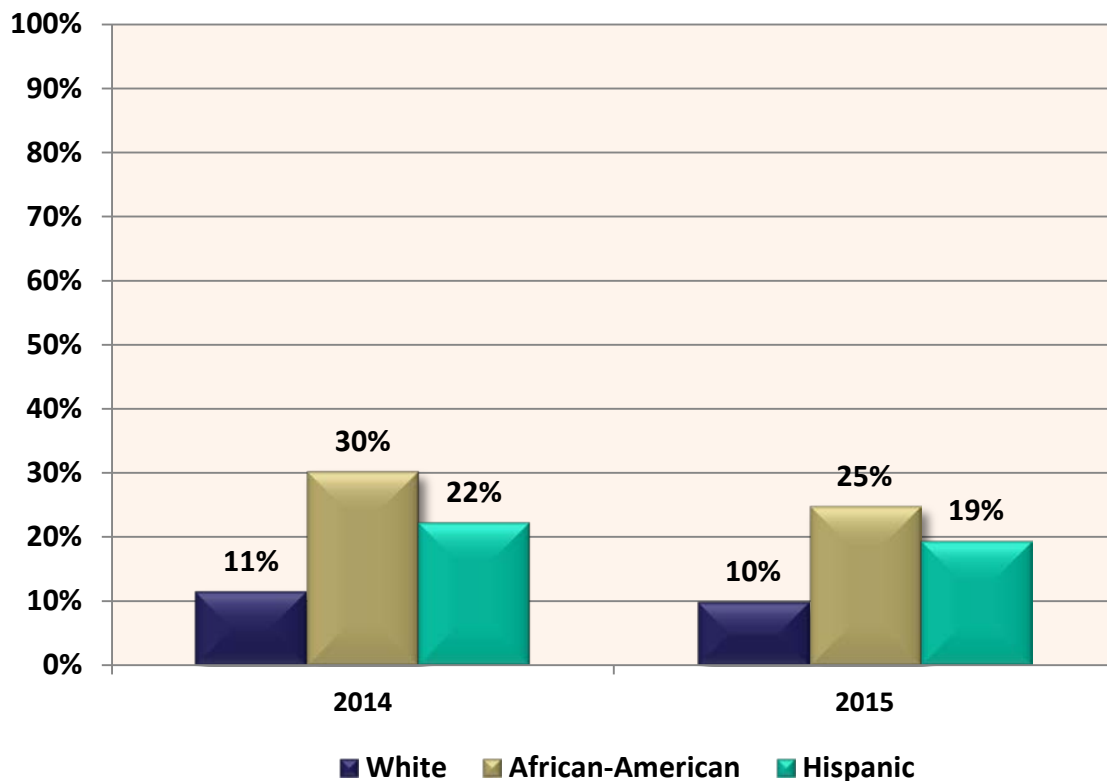

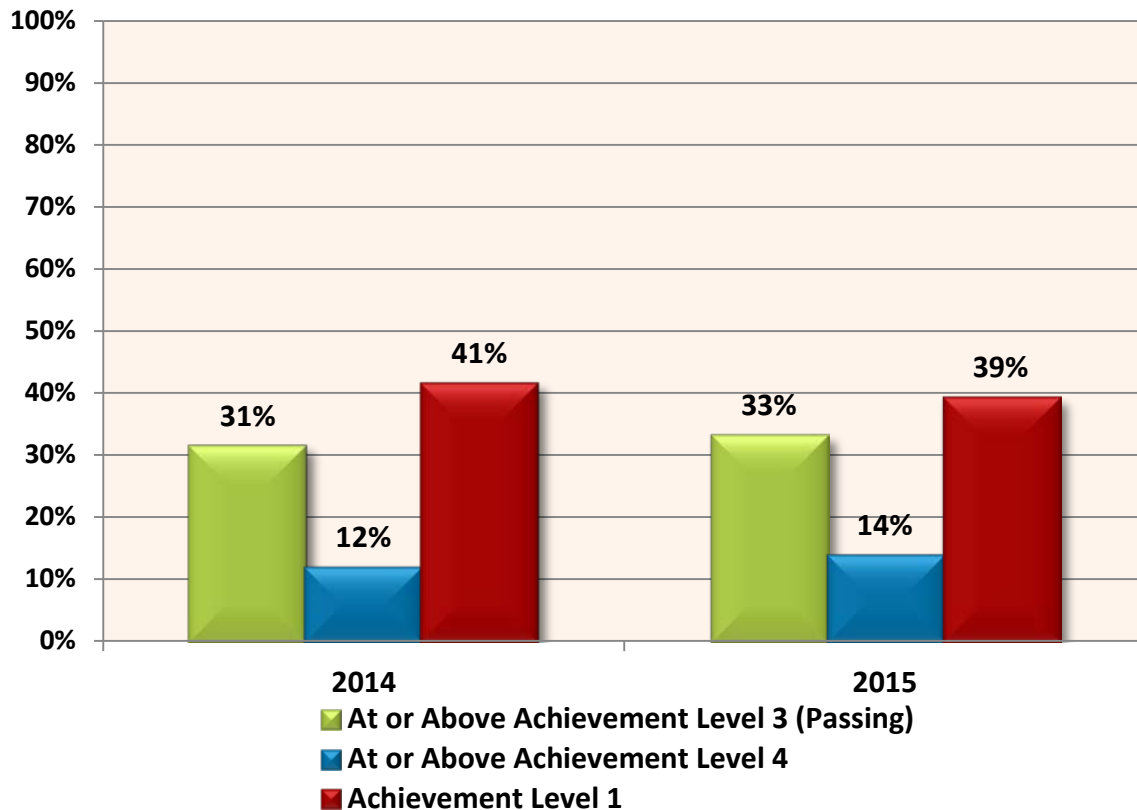

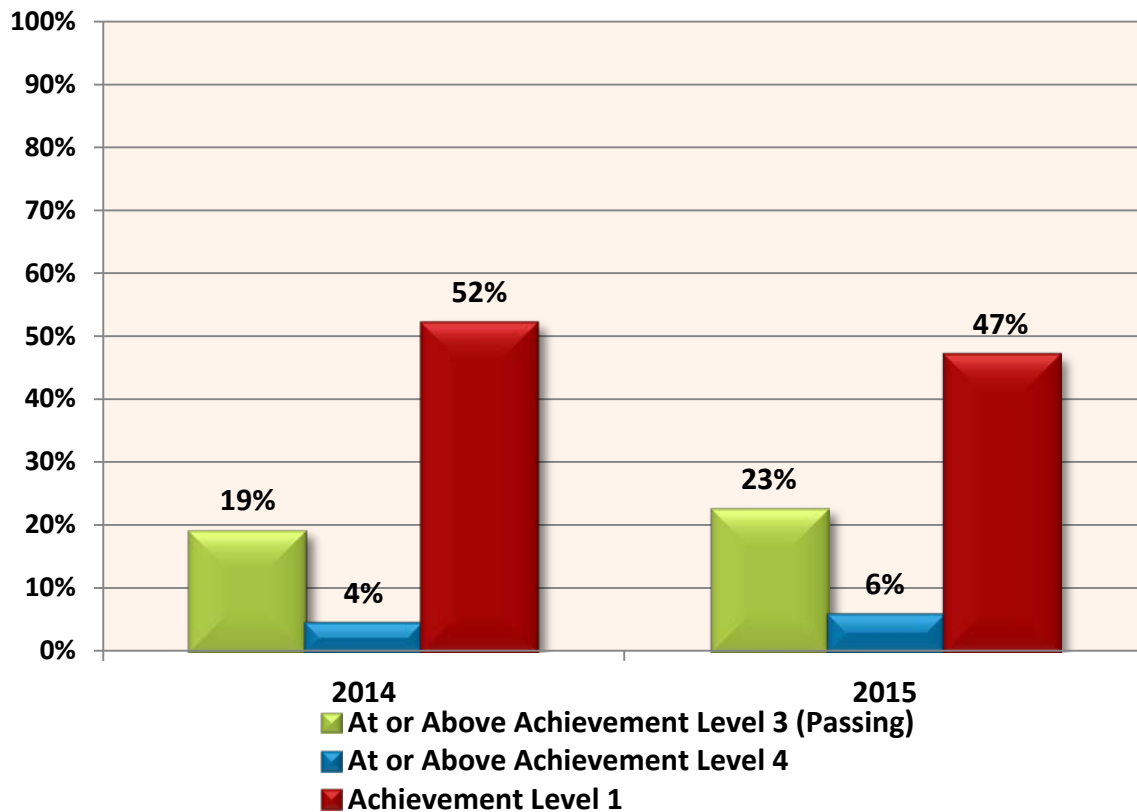

## Grades 6-8 Civics EOC Assessment By Achievement Level English Language Learners



Overall, English Language Learners in grades 6-8 improved performance on the Civics End-of-Course Assessment in 2015, with a 4 percentage-points increase at or above Achievement Level 3 (Passing), a 2 percentage-point increase at or above Achievement Level 4 and a 5 percentage-point decrease at Achievement Level 1.

In 2015, 23 percent of English Language Learners in grades 6-8 performed at or above Achievement Level 3 (Passing) on the Civics EOC Assessment. This is an increase from 19 percent in 2014. In 2015, 6 percent of English Language Learners in grades 6-8 performed at or above Achievement Level 4 on the Civics EOC Assessment. This is an increase from 4 percent in 2014. In 2015, 47 percent of English Language Learners in grades 6-8 performed at Achievement Level 1 on the Civics EOC Assessment. This is a decrease from 52 percent in 2014.
