SUBJECT: October 2008-09 Transportation Survey

The October 2008-09 student transportation survey will be conducted the week of October 13-17, 2008. The Automated Student Information System (student transportation format) is used by all districts to transmit their October student transportation information.

this data must be addressed prior to Friday, November 14, 2008, the system cutoff date. The attached form letter, which certifies the adjusted student membership and the number of buses reported on the database, must be signed by the superintendent or designee and submitted no later than Thursday, November 20, 2008. The October student transportation information provided in this letter must match that reported in the database as of the system cutoff date. **Districts may use Transportation Report F63499 or F70092 to verify adjusted membership and bus information recorded in the database for use in the certification letter.** The information in this letter will be compared with the Department's report to ensure that accurate information is used in the transportation funding formula.
