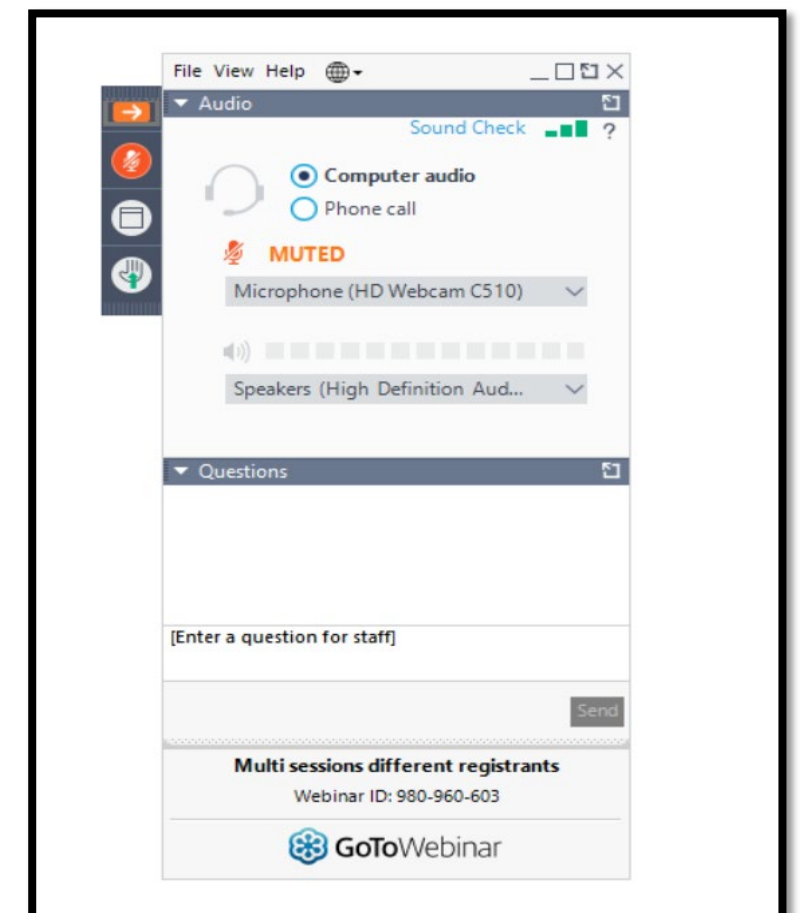

Risk Assessment

Implementation of a Risk-Based System

- Based on project and provider risk;
- Collaborative in nature;
- Recognizes positive practices;
- Identifies findings and concerns related to program quality and compliance; and
- Supports systemic and continuous program improvement

Risk Assessment Factors 2021-22

Risk Matrix – Operational Risk Factors (Metrics)

- Last monitoring review
- Number of grants
- Total budget of the Perkins V CTSO grant
- Unexpended grant funds
- Change in executive director

Risk Assessment Process

- Risk score divided into quartiles
- Balanced weight between data elements

Upper Quartile/Higher	7
Upper Middle	5
Lower Middle	3
Lower Quartile	1
Zero	0

Risk Assessment Process

Calculation of the Risk Score:

Point Value Assigned X Weight = Total Metric Point

Sum of all Metric Points = Agency Risk Score

IMPORTANT! A high risk assessment score should NEVER be interpreted as a negative reflection on the provider.

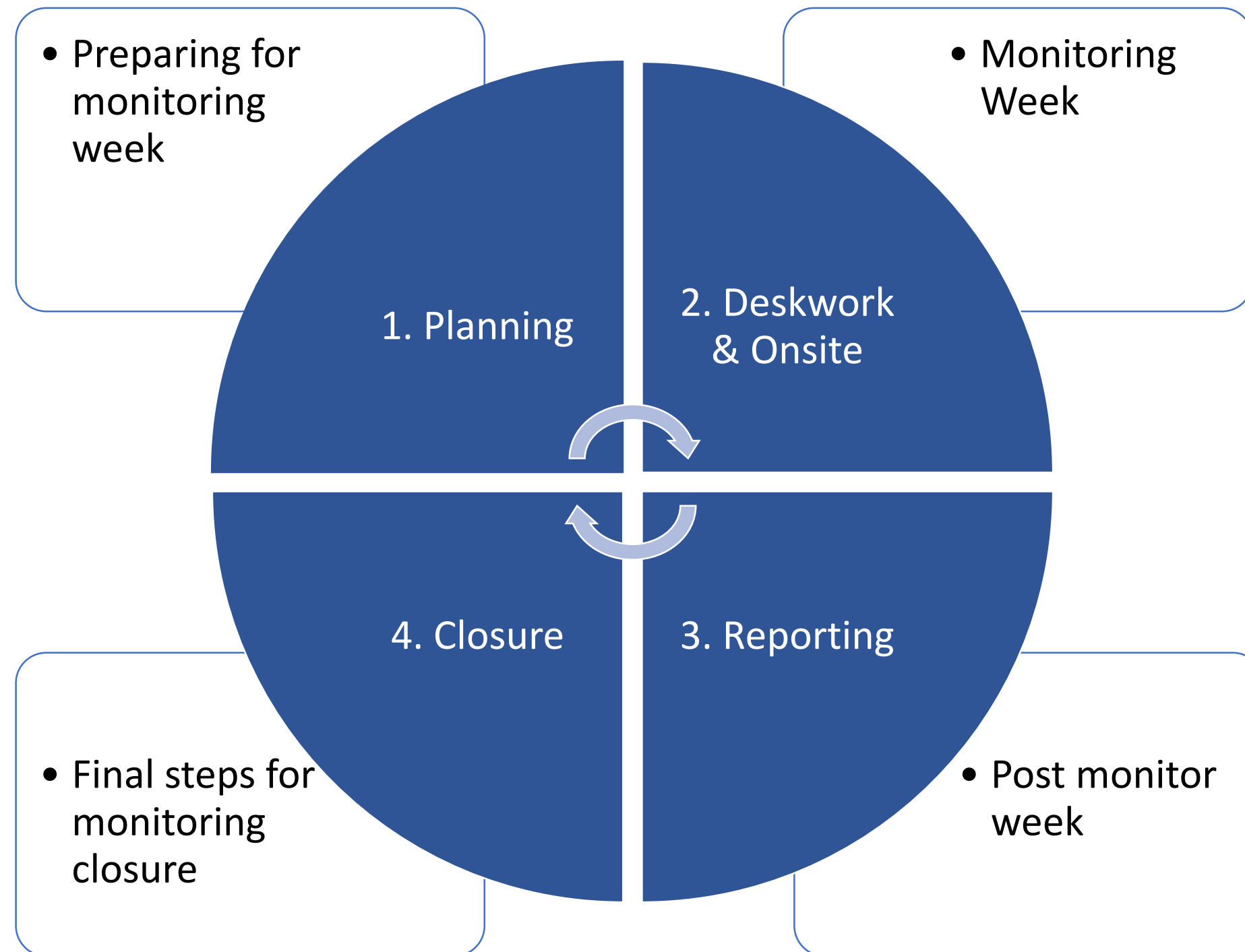

Monitoring Strategies

- Phone calls
- RFA / RFP reviews
- Records reviews (quarterly deliverables)
- Technical assistance
- Corrective action plans (if necessary)
- Referral for fiscal review
- Verification activities
- Investigations

Pre-Monitoring Activities

- Notification (personal and letter correspondence)
 - Personal contact with Director of CTSO
 - Letter from Chancellor to Agency Head
 - Memorandum from Director of Quality Assurance and Compliance
- Conference calls
 - Training for providers (August and December)
- Pre-visit meeting with FDOE staff

FDOE ShareFile

Purpose

- Citrix ShareFile® is the Florida Department of Education's (FDOE) cloud-based secure file transfer solution. This solution is used to transfer files that are confidential, as well as too large and/or too numerous to send in a single email.
- Maintain compliance with The Family Education Rights and Privacy Act (FERPA).

Virtual Desk Monitoring Activities

- Virtual Interviews
 - Executive leadership (if necessary)
- Records Review (2018-19, 2019-20, 2020-21 and 2021-22)
 - Evidence of acceptable documentation (deliverables)
 - Supporting documentation that may not be included with the quarterly deliverables
- Exit Conference

Post-Monitoring Activities

- Post monitoring meeting with FDOE staff
- Thank you letters
- Evaluation Survey
- Monitoring Report
 - Preliminary Draft – sent to provider contact for feedback
 - Final Report- sent to Agency Head
- Resolution activities
 - Corrective Action / Action Plans
 - Follow-up communication
- Closure

Examples of Monitoring Findings



Examples of Monitoring Findings

- Records retention – no access to records and/or backup documentation
- Evidence of acceptable documentation not submitted in a timely manner
- Receiving payment for deliverables that are non-existent or incomplete

General Concerns

- Not meeting goals as defined in your grant application and/or not adhering to the agreed upon evidence of acceptable documentation.
- Missing documentation and records
- Continuous need for time extensions and delays in submitting deliverables

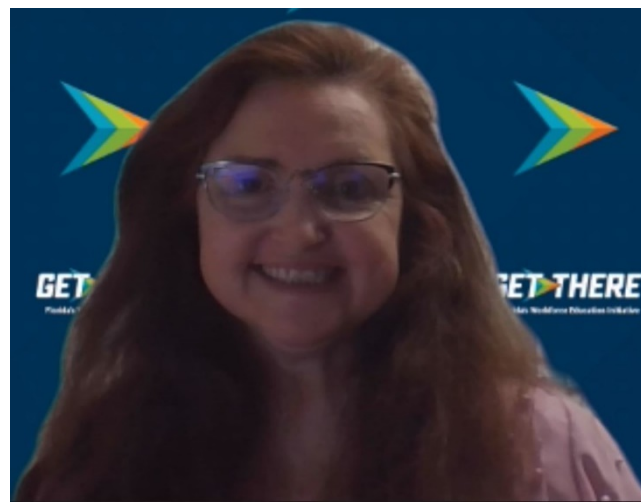

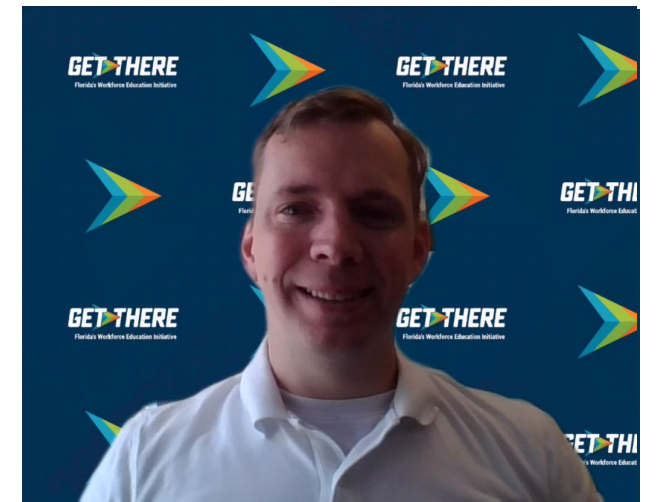
