

## John M. McKay Scholarship Program

## February 2021 Quarterly Report

The John M. McKay Scholarships for Students with Disabilities Program allows parents of students with disabilities to choose the best academic environment for their children. This program provides eligible students the opportunity to attend a participating private school or transfer to another public school. Eligible students include students who have been issued an Individualized Education Plan (IEP) or a 504 Accommodation Plan that is effective for more than 6 months.

This report contains private school and student statistics for the September 2020, November 2020, and February 2021 payment periods of the 2020-21 school year. All student participant numbers presented in the report reflect those who have received funding for the McKay scholarship program. Students who were enrolled in McKay but did not receive funding (i.e. unenrolled from program, change of program) are not reflected in this report. Percentages are rounded.
