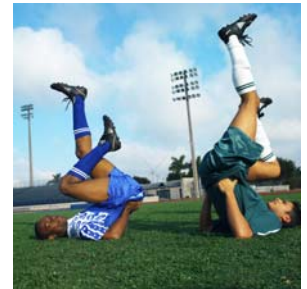
Looking Ahead: 2008 DOE Information Database Workshop

Mark your calendars! EIAS is hosting the annual Database Workshop June 17-19, 2008, at the Florida Hotel and Conference Center in Orlando. We will cover updates in procedures and requirements related to the DOE Information Database system. The workshop will provide an overview of the state's current student, staff, and finance database requirements for both technical and program staff in districts. This year we will also work in partnership with the Office of Independent Education and Parental Choice to offer training to district and charter school staff. Physical Education Reporting

The Florida Legislature passed HB 697 during the 2007 session. This bill was effective July 1, 2007, and

- Requires each district to provide 150 minutes of physical education (PE) weekly for students in Kindergarten through 5th grade
- Encourages districts to provide 225 minutes of PE weekly for students in 6th through 8th grades
- Defines reporting surveys to be Surveys 1 through 4
- Identifies personnel who provide instruction



Please remember

- According to legislation, all minutes for the PE requirement are to be reported in the Physical Education and Dance course numbers, not in the Health course numbers.
- The PE requirement in grades 6 through 8 (225 minutes) is recommended, not mandatory, but the Legislature is closely reviewing the data.
- All public elementary schools, including Department of Juvenile Justice (DJJ) and other special schools, are subject to these legislative requirements.
- Students with disabilities are subject to this mandate, as per federal law §300.108 (IDEA); they may not be "exempted."

Exciting News!

Florida was one of only ten states to receive permission from the U.S. Department of Education to report Exceptional Student Education (ESE) discipline and personnel data through the Education Data Exchange Network (EDEN). This is an exciting development that, in contrast to previous years' reporting, allows for greater accuracy and a smoother reporting process.

Request for 2008-09 Changes

The Education Information Services office is drafting revisions to the student and staff database elements and edits for the 2008-09 data reporting year. We are seeking your assistance in identifying needed changes that would lead to more efficient data collection and would increase the quality of data submitted to the department. Reporting Reading Assessment Data

When reporting Reading Intervention information it is important to remember:

- At the elementary level, a student not meeting grade level expectations, including students scoring a Level 1 or Level 2 on FCAT, must receive intensive intervention.
- All students in grades 6 through 10 scoring Level 1 or Level 2 and students in grades 11 and 12 who have not achieved a score of 1926 or higher on the FCAT in reading must receive reading intervention.
- All courses used for reading intervention (whether provided in a reading course or a content area course) must be coded for these students using the appropriate indicator code on the Reading Intervention Component element on the Student Course Schedule format.
- Schools that are not using the Progress Monitoring and Reporting Network (PMRN) to report student assessment data must report Reading assessment data via the 2007-08 Automated Student Database system, which is equipped to receive the progress monitoring measures listed in the district's approved K-12 Comprehensive Reading Plan.

Accountability Matching

EIAS, as part of the regular Survey 3 student database processing cycle, is conducting the matching between Survey 2 and Survey 3 data to identify full-year students. For the purposes of determining school grades and adequate yearly progress (AYP), students are included in the calculations only if they are "full-year students," defined as being enrolled in the school for both October 2007 FTE week (Survey 2) and February 2008 FTE week (Survey 3). During this process, the department provides districts with several opportunities to verify and correct all accountability related data. To ensure the timely calculations of school grades and AYP, districts must correct their data within the specific timeframes. The department will not accept corrections outside these timeframes, and uncorrected data are not grounds for appeals.
