KEEP KIDS SAFE AND EARN CASH FOR YOUR SCHOOL!

The Florida Asthma Coalition is still accepting applications for their Asthma-Friendly School Recognition (Deadline: May 15, 2015). To learn more and apply, please visit: www.floridaasthmacoalition.com/schools.

Asthma, a chronic lung disease, is one of the main reasons that students miss school due to illness. It is estimated that 466,112 instructional hours were lost due to asthma in Florida during the 2013-2014 school year. When students have their asthma in control, they perform better academically and miss less school. Schools with asthma management programs are the key to success, and the Florida Asthma Coalition and the Florida Healthy Kids Corporation are rewarding those that make asthma a priority.

Criteria & Recognition Levels

Recognition is offered at four levels: Bronze, Silver, Gold and Platinum. Cash awards will be made until designated funding runs out. Get your application in early to qualify!

Bronze: \$500

- 1. Asthma leadership team established.
- School nurses, faculty and staff participate in asthma training at least every other school year.
 Note: Participation requirements increase based on award level see Application Guide.
- 3. School ensures immediate access to asthma medications per Section, 1002.20(3)(h), Florida Statutes.
- 4. School provides student-centered asthma management support. Note: Requirements increase based on award level see Application Guide.
- 5. School displays asthma posters in high-traffic areas.
- 6. School provides physical education and activity opportunities that meet the needs of children with asthma.

Silver: \$750

All of the above and...

- 7. School works with community partners to provide self-management education to students with asthma.
- 8. School works with community partners to offer education to parents about asthma management.

Gold: \$1,000

All of the above and...

9. School maintains a healthy school environment through implementation of an indoor air quality program.

Platinum: \$1,500

All of the above and...

10. School implements comprehensive asthma procedures or a policy which includes the activities listed in criteria 1-9, and the district meets the 12 criteria for a comprehensive tobacco-free schools policy (See the article below).

Florida School Districts Embrace Comprehensive School Tobacco Policies

Florida is at the forefront in implementing innovative ways to reduce rates of tobacco-related deaths, diseases and disabilities. The Florida Department of Health's Bureau of Tobacco Free Florida, along with state partners, implement strategies that promote cessation, eliminate exposure to secondhand smoke and prevent initiation of tobacco use, especially among youth. One initiative having a large population-based impact is the implementation of a comprehensive tobacco-free school policy at the district level. Tobacco Free Florida has identified 12 key components of a comprehensive school tobacco policy (see list below). Through education and support from local staff and partners, school districts understand the impact of each component and how to integrate them into policy.

Students Working Against Tobacco (SWAT) youth have had a key voice in advocating for tobacco-free school policies. There is one SWAT Chapter in each of Florida's 67 counties. Additionally, many counties maintain school and community-based SWAT clubs. The SWAT youth team up with their adult volunteer counterparts to educate local school decision-makers about the influence tobacco has on youth and how the schools can adopt policies to counter this influence. The current results are shown below.

- Sixty-one percent of all counties in Florida have adopted a comprehensive 12-component tobacco policy.
- Eighty-one percent of all counties in Florida have adopted at least 10 of the 12 components, and 72 percent have all but one component.
- Out of the 2.71M students in Florida, more than 1.74M (64 percent) are covered by a comprehensive 12-component policy.
- More than 2.25M students (83 percent) are covered by 11 or more components.

The comprehensive policies include the following components:

- 1. Policy includes a statement of rationale for the policy and definitions of tobacco and tobacco use.
- 2. Tobacco is specifically named; not implied by prohibiting drugs.
- 3. All components of the policy are effective 24 hours a day; 365 days per year.
- 4. All school buildings, grounds, campuses, housing and property (including vehicles and buses), whether owned or leased, are tobacco-free at all times.
- 5. Students are prohibited from possessing and/or using tobacco products on school grounds and at school events, whether on or off district property.
- 6. School staff is prohibited from using tobacco products on school grounds, at school events, whether on or off district property.
- 7. Visitors are prohibited from using tobacco products on school grounds and at school events, whether on or off district property.
- 8. Wearing clothing or using other items that advertise or promote tobacco products is prohibited.

- 9. Tobacco advertising and acceptance of gifts, including curriculum, from tobacco companies is prohibited.
- 10. A plan to communicate the policy to all students, employees and visitors is outlined.
- 11. An enforcement plan for students, staff and visitors is outlined.
- 12. An enforcement plan for students and staff that provides cessation resources is outlined.

In partnership with two local art groups, the "RAW Project" – Reimagining the Arts in Wynwood, was born. Seventythree artists agreed to help with the project and paint murals on the school walls.
