GED® Updates

- 2020-2021 Framework Changes:
 - GED®-I only requires testing at level 5 or above in one approved test subject area for enrollment
 - No other changes at this time but will be reviewed for alignment with B.E.S.T. Standards
- GED® Testing Updates:
 - In-Person Testing is occurring at certain sites as per CDC guidelines
 - Florida will be participating in Phase 2 of GEDTS®
 pilot on-line proctored GED® tests during the
 summer. FLDOE and GEDTS® will evaluate results and
 will determine the feasibility for future use in Florida.

Integrated Education and Training (IET)

What is Integrated Education & Training (IET)?

- Workforce Innovation and Opportunity Act (WIOA) definition:
- It is a service approach that provides adult education and literacy activities <u>concurrently</u> and <u>contextually</u> with workforce preparation activities and workforce training for a specific occupation or occupational cluster for the purpose of education and career advancement.



Integrated Education and Training (IET)

- All IET programs must include the following <u>three</u> components:
 - Adult education and literacy activities (§463.30) (delivered through the adult education frameworks);
 - Workforce preparation activities (§463.34) (delivered through the adult education frameworks); and
 - Workforce training for a specific occupation or occupation cluster which can be any one of the training services defined in section 134(c)(3)(D), of WIOA (delivered through a locally adopted curriculum).
- The integrated education and training program must have a <u>single set of learning objectives</u> that identifies specific adult education content, workforce preparation activities, workforce training competencies and the program activities function cooperatively.



Integrated Education and Training (IET) Cont.

- In order to meet the "integrated" requirement of IET, all services must include the following:
 - Adult education and literacy activities run cooperatively and contextually with workforce preparation activities and workforce training for a specific occupation or occupational cluster for the purpose of educational and career advancement (translation: students are enrolled in a single AGE program number that is delivering instruction through IET);
 - Activities are of sufficient intensity and quality, and based on the most rigorous research available, particularly with respect to improving reading, writing, mathematics and English proficiency of eligible individuals;
 - Occur simultaneously; and
 - Use relevant occupational instructional materials.



IET, WIOA Then (2016) and Now (2020)

2016 WIOA State Plan

- Modeled after the I-BEST model from Washington state
- Simultaneous enrollment in adult education and a CTE career certificate program
- Limited to GED®-I and ELCATE (high functioning levels)
- Hallmarks were team teaching between adult education teacher and CTE teacher
- Culminated in completion of GED®-I and ELCATE and the award of an OCP (represents completion of part of a program) or a career certificate (represents completion of an entire program)
- Pre-IET was defined as an adult education instructional service approach (also referred to as a "contextualization") wherein adult education course and program instructional standards are taught contextually for a specific occupation or occupational cluster for the purpose of educational and career advancement.



IET, WIOA Then (2016) and Now (2020) Cont.

2020 WIOA State Plan

- IET is contextualized instruction! It is an adult education instructional service approach (also referred to as a "contextualization") wherein adult education standards are taught contextually for a specific occupation or occupational cluster for the purpose of educational and career advancement.
- This new IET approach is not limited to specific functioning levels in ABE (levels 1-6) and ESOL (levels 1-6).
- It is recommended that a cohort-based model be used when delivering IET and a collaborative partnership between AGE instructors and CTE teachers be utilized for consultation purposes.
- The goal is for students to advance functioning level(s) and springboard into related postsecondary study and employment with the academic skills needed for success.



Sample Instructional Delivery Models for Adult Education

Traditional Model – Delivery of the adult education standards in the curriculum framework which is inclusive of "workforce preparation" activities such as digital literacy, employability skills, critical thinking. Does not contextualize instruction.

IET Model – Delivery of the adult education curriculum framework in the context of a career cluster, pathway or occupation(s) through the utilization of a single set of learning outcomes.

Example: IET may introduce students to the Health Science Cluster and its five health science pathways and related occupations: Diagnostic Services, Therapeutic Services, Health Informatics, Support Services, Biotechnology Research & Development.



Sample IET Models

Mathematics — ABE Level One (1) Sunshine School District delivers traditional instruction	450 Hours	1 (0.0 – 1.9)
Mathematics for Manufacturing Careers — ABE Level Two (2) Sunshine School District delivers level 2 mathematics through IET at the Cluster Level	450 Hours	2 (2.0 – 3.9)
Mathematics for Manufacturing Pathways — ABE Level Three (3) Sunshine School District delivers level mathematics through IET at the Pathway Level with intrduction of all the associated occupations	300 Hours	3 (4.0 – 5.9)
Mathematics for Welding Careers — ABE Level Four (4)	300 Hours	4 (6.0 – 8.9)



IET Scenario-Based Questions

- Question: My district wants to operate a GED®/Welding IET program. Does this mean my district can teach the standards and benchmarks in the Welder Assistant 1 course (PMT 0070) through our comprehensive GED® preparation program?
- Answer: No. The Welder Assistant 1 course is part of a State Board of Education approved curriculum framework (career certificate program) that has specific teacher certification requirements and a specific tuition and fee structure.



IET Scenario-Based Questions (cont.)

 However, your district can utilize IET to teach the academic skills needed to learn the occupational skill associated with welding. For example, mathematics instruction that supports a welding course would teach fractions using activities to determine combining pipe lengths to complete a welding task (measurement).

Reporting Initial EFL without a Pre-Test

- Memo was sent June 6th
- Applies to students who are unable to be pretested prior to enrolling because of the closures
- Local assessments and evaluations can be used to determine an appropriate program, but should not be used to establish a specific EFL or report learning gains



Reporting Initial EFL without a Pre-Test-ABE

 Scenario 1: Based on a locally determined method, student is enrolled in Adult Basic Education

Initial EFL reported if student is unable to be pre-tested with an approved NRS assessment before the end of the term:	Report the student as ABE level 1.
Initial EFL reported when student is able to pre-tested using an approved NRS assessment before the end of the term:	If pre-test places the student into the ABE Program, update the provisionally assigned EFL based on the pre-test results. If pre-test placed them into GED Prep, continue to report the student as an ABE Level 1 for the remainder of the term. In the next term, enroll the student in GED and report the correct initial EFL based on the approved pre-test.



Reporting Initial EFL without a Pre-Test-ABE

 Scenario 2: Based on a locally determined method, student is enrolled in GED® Prep

Initial EFL reported if student is unable to be pre-tested with an approved NRS assessment before the end of the term:	Report the student as ABE level 5.
Initial EFL reported when student is able to pre-tested using an approved NRS assessment before the end of the term:	If pre-test places the student into the GED® Program, update the provisionally assigned EFL based on the pre-test results.
	If pre-test places the student into the ABE program, continue to report the student as an ABE Level 5 for the remainder of the term. In the next term, enroll the student in ABE and report the correct initial EFL based on the approved pre-test.



Reporting Initial EFL without a Pre-Test-ABE

 Scenario 3: Based on a locally determined method, student is enrolled in ESOL or ELCATE

Initial EFL reported if student is unable to be pre-tested with an approved NRS assessment before the end of the term:	Report the student as ESL Level 1.
Initial EFL reported when student is able to pre-tested using an approved NRS assessment before the end of the term:	Update the provisionally assigned EFL based on the pre-test results.



Reporting Changes for 2020-21- District

Adult Educational Functioning Level, Initial (DE 101075)

- The AGE Student Course Schedule will include three fields
 - Adult Educational Functioning Level, Initial (Non-ESOL and ELCATE Programs)
 - Adult Educational Functioning Level, Initial (ESOL/ELCATE Reading)
 - Adult Educational Functioning Level, Initial (ESOL/ELCATE Listening)
- Will be optional for Survey F and required beginning with Survey W



Reporting Changes for 2020-21- District

Adult Test Name(DE 101776)

- Added to the AGE Student Course Schedule
- Represents the test used to establish the Adult Educational Functioning Level, Initial



Reporting Changes for 2020-21-FCS

- EDIT- Adult Educational Functioning Level- Initial (DE 3022)
 - Will be limited to non-ESOL/ELCATE Programs
- NEW- Adult Educational Functioning Level-ESOL/ELCATE Listening (DE 3029)
 - Used for reporting the initial EFL based on a listening score
- NEW- Adult Educational Functioning Level-ESOL/ELCATE Reading (DE 3030)
 - Used for reporting the initial EFL based on a Reading score



Reporting Changes for 2020-21-FCS

NEW- Adult Test Series (DE 3031)

- Added to Record Type 6
- Represents the test used to establish the Adult Educational Functioning Level, Initial

- Additional Technical Assistance to be provided in the near future




District Workforce Education 504/ADAAA Resources Updated

Adult Education IET Instructional Delivery Approach- DRAFT

Reportable Value	Definition
A	Student is enrolled in an adult education course that delivers the adult education standards in the curriculum framework with fidelity which is inclusive of "workforce preparation" activities such as digital literacy, employability skills, critical thinking, career exploration activities. The course does not contextualize instruction at the career cluster or occupation level. This is not Integrated Education and Training (IET).
В	Student is enrolled in an adult education course that delivers the adult education curriculum framework through contextualized instruction and learning activities aligned with a specific career cluster. This method of instructional delivery is a form of IET.
С	Student is enrolled in an adult education course that delivers the adult education curriculum framework through contextualized instruction and learning activities aligned with a specific with a specific occupation(s) or postsecondary career technical education program. This method of instructional delivery is a form of IET.
D	Student is enrolled in an adult education course and is simultaneously enrolled in a career and technical education postsecondary program. This method of instructional delivery is a form of concurrent enrollment and not IET.
Е	Student is not enrolled in an adult education course that provides career exploration of contextualized learning activities.

Test Center COVID-19 Procedures

- Detailed Pearson VUE reference guide was emailed to all test administrators in late May (email Diane Vaccari if you need a copy)
- Here are a few excerpts:
 - Please follow your local and government guidelines for operating safely.
 - If you require testing candidates to follow additional safety measures that are not government-mandated, such as wearing face masks or having their temperatures checked, please detail these requirements in the 'directions' section of Site Manager so it is displayed in candidate confirmation letters.
 - Per standard process, please follow the site closure process if you need to close your test center and if you're unavailable for test appointments.

- Most Florida public testing centers are currently closed and to ensure access to testing to our state's residents Florida is participating the pilot
- Pilot has 4 phases and is currently in phase 2
- Pilot is expected to run until the end of July when GEDTS and FDOE will evaluate the outcome to determine future use in Florida



- Testing is mainly by invitation only. Invitations will be initiated in the following order:
 - Testers with cancelled tests.
 - Testers who have passed 3 of 4 subtests.
- Once invited, testers will be required to score in the "Likely to Pass" – Green range on the GED Ready within the last 60 days.
- The final invitations will be sent to any testers not previously invited who have earned "Likely to Pass"

 Green range on the GED Ready in the past 60 days.



- Currently, the only invitations that have been sent are to those with cancelled tests.
- An additional group of candidates who have not received an invitation can currently schedule OnVUE testing under the following conditions:
 - The individual has to have a GED Ready Green on the subject test they are trying to schedule
 - The choice of OnVUE testing appears when they choose to schedule the test from their dashboard at GED.com



- Not all testers will be able to participate in the pilot. The following will not be available during the pilot:
 - 16- and 17-year old testing (underage testing)
 - Spanish testing
 - Accommodated testing
 - Correctional facility testing
- If a tester does not pass a test taken through OnVUE, the individual will not be able to retest using OnVUE; retests will have to be scheduled at a local testing center.



- As GEDTS has conveyed in their presentations, they are not abandoning the traditional in-person test center model.
- This solution is being piloted to provide a way to get individuals tested during the pandemic and possibly be used in other specific situations when warranted.
- Even though your testing center may be open for testing it will likely be at limited capacity, and some individuals still may feel uncomfortable visiting your testing center in-person during the COVID19 pandemic.

GED® Testing – Vouchers

- GED® Testing/Pearson VUE vouchers are good for one year, so make sure to plan accordingly to only purchase what you will actually use in that time period. Here are a few tips to keep in mind:
 - Prior to ordering vouchers, plan out the number you will actually be able to use before they expire.
 - Monitor your inventory of current vouchers.
 - Have a plan in place for using your vouchers based on the expiration dates.
 - If you know you will be unable to use all of your vouchers by the expiration dates, contact us 4-6 weeks prior to expiration so that we can try to get them extended and/or reissued. (This is a last resort – plan accordingly to use your vouchers by the expiration date.)

2020-2021 Adult Education Grant Application Questions and Answers

Q: If an agency changes the enrollment number of the 1:E form, can we apply for the full allocation?

A: Yes, in response to the unique circumstances related to the current pandemic, the change enrollment population and instructional delivery methods.

Q: How do is submit the 2020-2021 Adult Education grant application?

A: The department is streamlining the submission process for your Adult Education grant applications for 2020-2021. All grant applications must be submitted to the Office of Grants Management Sharefile System.



2020-2021 Adult Education Grant Application Questions and Answers

Q: If I don't have our agency's MOU signed by the application due date will I still be able to have my grant awarded?

A: Yes, extended time is allowed due to the current pandemic situation. We will approve your grant under the contingency that we will have the signed agreement by December 31, 2020.

Submit the signed MOU through the grant amendment process.

Q: When can new eligible providers apply for Adult Education grant funds?

A: Program Year 2021-2022, will be the next competitive grant application period. The Request for Proposals (RFPs) will be released in January 2021 and posted on the Division's website.



2020-2021 Adult Education Grant Application Questions and Answers

Q: Where can I locate the list of eligible providers?
