# HB 1193 – Deregulation of Professions and Occupations

#### Effective January 1, 2021, the bill:

- Reduces Barbering hours from 1200 to 900. Rule 61G3-16.001
- Reduces Facial Specialty hours from 260 to 220. Rule 61G5-22.017
- Reduces Nails Specialty hours from 240 to 180. Rule 61G5-22.016
- All Rules to be Finalized by the Florida Board of Cosmetology and the Florida Barbers Board at the end of October and become effective on January 1, 2021.

# HB 171 – Postsecondary Education for Certain Military Personnel

- Established an Articulation Coordinating Committee (ACC) workgroup to develop the process for determining postsecondary course equivalencies and minimum postsecondary credit or career clock hours.
- First meeting July 14, 2020 and has continued to meet biweekly.
- By December 1, 2020, the work group will:
  - Establish a process for prioritizing and determining postsecondary course equivalencies;
  - Establish minimum postsecondary credit or career education clock hours that must be awarded for courses taken and occupations held by individuals during their service in the military; and
  - Provide recommendations to the Board of Governors and the State Board of Education for approval at the next meeting of each board to allow for adequate public notice.

# Status of COVID-19 Waivers for Clock Hour Programs

Commissioner Corcoran issued Department of Education <u>Emergency Order</u> (EO) 2020-01 on March 23, 2020, that provided flexibility to school districts and Florida College System institutions around the kinds of assessments used to determine basic skills functioning levels in clock hour programs that are 450 hours or greater pursuant to <u>s. 1004.91 F.S.</u> Requirements for Career Education Program Basic Skills and <u>Rule 6A-10.040 F.A.C.</u> Recently, we have received inquiries about the extension of this order. The department has updated the guidance as follows:

• For the 2020 fall semester only, programs are authorized to assess basic skills by any reasonable means and are not limited to the assessments listed in Rule 6A-10.040, F.A.C. or bound by the time limits set forth in order to exit a student who meets all other criteria for completion of a clock hour certificate programs that is 450 hours or greater.



# Status of COVID-19 Waivers for Clock Hour Programs Basic Skills Requirements

- A district or college cannot waive the requirement locally.
- However, the agency may assess basic skills locally by any reasonable means. You need to develop and document a local method for your alternative assessment(s).

# **EO-20-02 Continued Flexibility for CTE Curriculum Framework Requirements**

- Rule 6A-6.0571, F.A.C., incorporates the state curriculum frameworks by reference. The state inventory of career and technical education program frameworks specify program length and instructional standards (student learning outcomes).
- Currently, subsection 2 of the rule allows the Commissioner of Education to approve a school's waiver request submitted by a district school board or the Florida College System; institution's board of trustees to allow the school or institution to substitute locally approved intended outcomes for State Board-approved outcomes, provided the program is unregulated.
- Subsection 2 of this rule is waived to allow flexibility to locally waive certain instructional requirements in the frameworks, such as required work/field experience for unregulated programs. # **EO-20-02 Continued Flexibility for CTE Curriculum Framework Requirements**

- This provision does not apply to regulated programs and the remaining provisions (standard program length, teacher certification requirements, basic skills requirements (if applicable)) of the rule remain in place.
- The following is an example of how the waiver may be used:
  - Medical Assisting program requires the completion of 40 field hours in a clinical setting. This waiver allows districts the authority to locally waive this requirement and substitute other locally developed outcomes without Commissioner approval.
  - (Sample) agriculture-related standard: transport, groom and show selected livestock animals in exhibition setting state standard is locally modified to Demonstrate proper grooming techniques on selected companion or livestock animals via electronic synchronous or asynchronous means.
- This waiver runs consecutively with the Governor's emergency order 20-52 and is currently effective through January 2, 2021.

# 2020 Lower Division CIP Transition and Deployment

- NCES released the 2020 Classification of Instructional Programs (CIP)
  last year, which reflects the various programs of study being offered at
  postsecondary institutions around the country.
- The Division maintained the existing 2010 CIPs (Florida's 10-digit CIPs, which is inclusive of the 6-digit federal CIP) in the 2020-2021 curriculum frameworks and announced to school districts and FCS institutions that deployment of 2020 CIPs would be reflected in the 2021-2022 curriculum frameworks.
- On the upper division side, the Division of Florida Colleges has already engaged the Florida College System on the 2020 CIP assignments for workforce baccalaureate degrees.
- This month, school districts and FCS institutions can review and provide feedback on recommended lower division 2020 CIP code assignments for all program types (career certificate, ATD, CCC, AAS, and AS).
- Webinar is scheduled for November 18<sup>th</sup>



### 2020 Federal CIP Codes and Financial Aid

- In early October, FDOE was made aware that institutions must be using valid 2020 Classification of Instructional Program codes (federal 6-digit) for programs to continue to be eligible for Title IV financial aid in <u>2020-21</u>. FDOE plans to adopt the new CIPs in 2021-22; however, given the impact on Title IV, institutions should immediately begin using valid 6-digit 2020 CIP codes for impacted programs for Title IV purposes.
- In most cases, the 2020 6-digit CIP codes did not change from the 2010 6-digit CIP codes. For those programs, the institution can simply roll over the same federal 6-digit CIP code from 2010 to 2020. In other words, no action is needed relative to CIP codes for these programs to continue to be eligible for Title IV. There are, however, a handful of programs that do not have a valid 2020 CIP code. Institutions MUST input a valid 2020 6-digit CIP code to continue to process Title IV aid in 2020-2021.



### 2020 Federal CIP Codes and Financial Aid

- <u>Action Required:</u> Review the list of all programs that require a 2020 CIP update
  to determine if your institution offers or plans to offer any programs in 2020-21.
  For each program that is Title IV eligible, we encourage your institution to
  immediately transition to the new 6-digit CIPs for Title IV. If you have any
  questions about how to properly update the CIP codes in COD, please reach out
  to the COD Customer Relations Center at <a href="CODSupport@ed.gov">CODSupport@ed.gov</a>. If your
  institution does not offer or does not plan to offer these programs, no action is
  required.
- The FDOE is still planning to continue its previously discussed process for reviewing CIP assignments and associated SOC linkages for the 2021-22 reporting year. USDOE confirmed this timeline is acceptable so long as the institutions are using valid 2020 CIP codes in COD for the 2020-21 aid year. Therefore, for state reporting purposes, you may continue to use the current CIP code. Additional information regarding the transition will be forthcoming. ## Statewide Course Numbering System (SCNS) Clean-Up

- Pursuant to Florida Statute 1007.24(8), the Department of Education is asking all institution contacts at all SCNS-participating institutions to discontinue courses that they are no longer offering in the SCNS Database.
- Please keep in mind that even when the last college discontinues a course in SCNS, that course will stay in the SCNS taxonomy for five years. Colleges at any time in that five-year window can reinstate the course number that was discontinued.
- A course number will not be lost during the five-year period.
- Working with stakeholders on a multi-phased approach to consolidation of course numbers based on content and learning outcomes. More information is forthcoming.
