

**Program Fund Appropriations by Source and Per FTE Student** 







The Florida College System Comparison of FTE Students to Total Program Fund Appropriations per FTE, Lower and Upper Levels Combined



## **Proviso Requirements**

#### **Performance-Based Incentives**

- Funds are provided to colleges for students who earn industry certifications in the following occupational areas: public safety, health sciences, automotive service technology, auto collision repair and refinishing, marine engine repair, cyber security, cloud virtualization, network support services, computer programming, advanced manufacturing, electrician, welding, Federal Aviation Administration airframe mechanics, power plant mechanics, unmanned aircraft systems, pharmacy technicians, and heating, ventilation and air conditioning technicians.
- Updates for FY 2024-25: "Priority in the distribution of funds must be given to certifications earned in the highest tier, based upon the anticipated average wages of all occupations to which each certification is linked on the Master Credentials List, as reported annually to the Legislature pursuant to section 1011.81, Florida Statutes."



### **Audits**

- 11 Operational Audits received as of May 30, 2024
- 30 total findings
- Background Screenings
  - 2 colleges
  - Required background screenings were not always conducted for college employees and were not always timely performed and documented.
- Laboratory Fees
  - 2 colleges
  - College records did not always demonstrate compliance with state law and college procedures by limiting laboratory fees to the cost of services provided.
- Extra Compensation and/or Bonus Awards
  - 2 colleges
  - College records did not demonstrate compliance with state law by extra compensation payments to employees after services have been rendered.



## **Audits (continued)**

#### Tangible Personal Property

- 3 colleges
- The college did not provide appropriate accountability over tangible personal property. In most cases, a complete physical inventory of the property has not been conducted for years which increases the risk of loss or theft without timely detection and investigation.

#### Information Technology User Access Privileges

- 2 colleges
- The college has some unnecessary information technology user access privileges that continue to exist, increasing the risk for unauthorized disclosure of sensitive student information to occur.

#### Student Accounts Receivable

- 3 colleges
- College personnel controls over delinquent student receivables could be enhanced and were not always timely reported to collection agencies.

## **FCO Budget Timeline**


- Colleges submit Capital Improvement Plan (CIP) to DFC by Monday, July 1, 2024. (MUST BE BOARD APPROVED)
- FDOE develops priority list, to be included in the agency's LBR.
- FDOE's LBR is submitted to Governor's office, House and Senate by October 15 each year.
- Back-of-bill items updated in November/December.
- 2025 Session is scheduled to start March 4 and end May 1.

#### **HB 5101 Education**

#### **After Conference and Before Governor's Actions**

Section 1. Amends Section (s.) 110.123,
 Florida Statutes (F.S.), State group insurance program, to include Florida College System (FCS) institutions in the State Group Health Insurance Program.

The initial enrollment period is required to begin as soon as practicable, with coverage beginning in the 2025 plan year no later than July 31, 2025.



#### **HB 5101 Education cont.**

#### **After Conference and Before Governor's Actions**

- Section 4. Amends s. 1002.33, F.S., Charter schools, to modify the methodology to calculate state funds and capital outlay funds for charter schools sponsored by an FCS institution or a state university and designates that the FCS institution or university is the fiscal agent for sponsored charter schools.
- Section 23. Amends s. 1011.62, F.S., Funds for operation of schools, to authorize charter schools sponsored by an FCS institution or state university to receive the state-funded discretionary contribution that funds the nonvoted discretionary millage for operations.



#### **HB 5101 Education cont.**

#### **After Conference and Before Governor's Actions**

Section 26. Amends s. 1013.62, F.S., Charter schools capital outlay funding, to specify that a charter school sponsored by an FCS institution or a state university that receives state funding for capital improvement purposes per s. 1002.33(17)(b)2., F.S., is not eligible to receive capital outlay funds.



#### **HB 149 Continuing Contracts**

#### **After Conference and Before Governor's Actions**

# HB 151 Florida Retirement System (FRS) Chapter No. 2024-92, Laws of Florida

- Section 1. Authorizes an FRS retiree to be re-employed with an FRS employer and receive both compensation and retirement benefits after the six (6) calendar months immediately following the date of retirement. (s. 121.091, F.S.). Effective July 1, 2024.
- Section 2. Effective July 1, 2026, the FRS Preservation of Benefits Plan is closed to new members (s. 121.1001, F.S.).
- Section 3. Establishes the contribution rates paid by FRS employers beginning July 1, 2024. The rate for Regular Class increases from 4.78% to 4.84%. Special Risk Class increases from 11.95% to 12.07%. The 3% employee contribution remains unchanged. (S. 121.71, F.S.)



# SB 674 U.S.-produced Iron and Steel in Public Works Projects After Conference and Before Governor's Actions

- Creates ss. 255.0993, F.S., Public works projects; United States-produced iron and steel products.
- Requires a governmental entity (including higher education institutions) that contracts for a public works project to include a requirement in certain contracts that certain iron or steel products be produced in the U.S.



# SB 674 U.S.-produced Iron and Steel in Public Works Projects After Conference and Before Governor's Actions

- Authorizes the minimal use of foreign steel and iron materials in certain circumstances.
- Exempts specified products from the requirement.
- DMS to develop guidelines and procedures by rule to implement. Effective July 1, 2024.



### SB 818 Military Leave Chapter No. 2024-19, Laws of Florida

 Amends ss. 115.09 and 115.14, F.S., to require a public employer to provide an employee or official who is a servicemember a full paid leave of absence for the first 30 days of active military service when activated under federal military service that is equal or greater than 90 consecutive days. Effective July 1, 2024.



#### **HB 917 Career and Technical Education**

- Adds to the duties of the Office of Reimagining Education and Career Help (REACH) to study the status of career and technical education (CTE) in each school district within the state, and report findings by March 1, 2025. The REACH Office must also coordinate an annual statewide report on the supply and demand of nursing occupations (s. 14.36, F.S.).
- Repeals the Florida Talent Development Council (s. 1004.015, F.S.).



#### **HB 917 Career and Technical Education cont.**

- Provides a uniform standard for counties and municipalities to issue a license to a journeyworker (s. 446.021, F.S.).
- Allows minors aged 16 or 17 to work in residential construction if certain requirements are met (s. 450.061, F.S.).
- Exempts a student who possesses a high school diploma from career education program basic skills if they graduated from a compliant private school or completed a home education program or a personalized education program (s. 1004.91, F.S.).



#### **HB 1083 Permanency for Children**

- Section 6. Revises s. 39.6225(9), F.S., Guardian Assistance Program.
- Section 14. Revises s. 409.1451, F.S., The Road-to-Independence program.
- Section 15. Revises s. 409.166(4), F.S., Adoption Assistance.
- Reduces the age requirements for receiving postsecondary education services and support, and adoption assistance from age 16 to age 14.



# SB 1264 History of Communism Chapter No. 2024-102, Laws of Florida

- Requires instruction on the history of communism in public schools (s. 1003.42 (2)(v)1., F.S.). (Amend rule 6A-1.09441.)
- Creates the Institute for Freedom in the Americas at Miami Dade College to promote economic and individual freedoms with an emphasis on Latin America and the Caribbean (s. 1004.89, F.S.).
- Renames the Adam Smith Center for the Study of Economic Freedom at Florida International University (s. 1004.64991, F.S.).
- Department of State and FDOE to collaborate and recommend the creation of a museum of the history of communism on or before December 1, 2024.
- Effective date: July 1, 2024.



# HB 1285 Education Chapter No. 2024-101, Laws of Florida

- Creates s. 288.036, F.S., Ocean economy development.
   Creating the Office of Ocean Economy to be housed at
   Florida Atlantic University, to foster relationships and
   coordination between state universities, private universities,
   and Florida College System institutions, in turning innovative
   technology into marketable goods and services.
- Clarifies s. 1001.61 (3), F.S., that members of an FCS institution board of trustees are subject to Florida ethics laws for public officers with respect to business dealings with any institution under their purview while they are a member.



# HB 1285 Education cont. Chapter No. 2024-101, Laws of Florida

- Creates s. 1004.051, F.S., Regulation of working students.
   Specifies a public postsecondary institution may not prohibit an applicant or student from being employed, subject to certain exceptions.
- Amends s. 1006.38, F.S., to require that publishers make electronic versions of student editions of instructional materials available to teacher preparation programs and educator preparation institutes at a discount below publisher cost.
- Amends s. 1007.25 (9), F.S., to create a new associate in arts specialized transfer degree for students who need additional credit above the 60 hours in preparation for transfer to a baccalaureate degree program. (Amend rules 6A-14.030, 6A-14.0303, 6A-10.024 and 6A-10.02413.)



# HB 1285 Education cont. Chapter No. 2024-101, Laws of Florida

- Amends s. 1007.271, F.S., Dual enrollment programs, to require district school boards to make reasonable efforts to enter into dual enrollment articulation agreements with FCS institutions that offer online dual enrollment courses.
- Revises s. 1009.21, F.S., Determination of resident status for tuition purposes, to allow documentation of homestead exemption as a single piece of evidence proving residency for tuition purposes. (Amend rule 6A-10.044.)
- Adds paragraph (22) to s. 1009.23, F.S., FCS institution student fees, authorizing Miami Dade College, Polk State College and Tallahassee State College to charge an amount not to exceed \$290 per credit hour for nonresident tuition and fees for specified distance learning programs.



# HB 1285 Education cont. Chapter No. 2024-101, Laws of Florida

 Repeals s. 1012.86, F.S., FCS institution employment equity accountability program, and revises s. 1001.64 (19), F.S., FCS institution boards of trustees; powers and duties, and s. 1001.65 (22), F.S., FCS institution presidents; powers and duties accordingly.



# HB 1291 Educator Preparation Programs Chapter No. 2024-141, Laws of Florida

- Modifies statutory requirements for courses and instruction in initial teacher preparation programs (s. 1004.04, F.S.), education preparation institutes (s. 1004.85, F.S.), professional learning certification programs (s. 1012.56, F.S.), and school leader preparation programs (s. 1012.562, F.S.) to specify such programs:
  - May not distort significant historical events, teach identity politics, violate Florida law regarding discrimination, or base coursework or instruction on specified theories regarding social, political, and economic inequities.
  - Must afford teacher candidates the opportunity to think critically, achieve mastery of academic content, learn instructional strategies, and demonstrate competence; and afford school leader candidates the opportunity to demonstrate mastery of program content, including instructional leadership strategies, coaching development, and continuous improvement efforts. Effective July 1, 2024.



### **HB 1473 School Safety**

Section	Present	Proposed
4	Section 985.04, F.S., Oaths; records; confidential information. Paragraph (4)(a) currently reads: Notwithstanding any other provision of this section, when a child of any age is taken into custody by a law enforcement officer for an offense that would have been a felony if committed by an adult, or a crime of violence, the law enforcement agency must notify the superintendent of schools that the child is alleged to have committed the delinquent act.	Adds: If the student is a dual enrolled student at a postsecondary institution,

#### **HB 1645 Energy Resources**

 Section 2. Revises s. 286.29, F.S., Climate-friendly public business to energy guidelines for public business. It deletes the requirements related to the Florida Climate-Friendly Preferred Products List, Green Lodging Program, and state vehicle fuel efficiency. Effective date July 1, 2024.



#### **SB 7002 Education**

### SB 7004 Education (Deregulation)

- Section 1. Removes the requirement for the State Board of Education to establish the tuition and out-ofstate fees for developmental education and associate degree credit (s. 1001.02, F.S.).
- Section 2. Removes the requirements for the State Board of Education to identify performance metrics for the FCS and develop a plan that specifies goals and objectives for each FCS institution (s. 1001.03, F.S.) that are separate from the State Board's Strategic Plan.
- Section 17. Repeals s. 1004.925, F.S., Automotive service technology education programs; certification.



## SB 7004 Education (Deregulation) cont.

- Section 21. Removes obsolete language regarding baccalaureate degree approval at St. Petersburg College (s. 1007.33, F.S.).
- Section 28. Removes obsolete language regarding the State Board of Education annually evaluating the performance of the executive director (s. 1008.45, F.S.).



# HB 7007 Campus Emergency Response Chapter No. 2024-41, Laws of Florida

- Amends s. 1004.0962(4), F.S., to state: "That portion of a public meeting which would reveal information related to a campus emergency response is exempt from s. 286.011 and s. 24(b), Art. I of the State Constitution."
- Deletes paragraphs (5) and (6).
- Effective October 1, 2024.



## SB 7016 Health Care Chapter No. 2024-15, Laws of Florida

- Section 1. Amends s. 381.4019, F.S., Dental Student Loan Repayment Program to add dental hygienists and a volunteer program to support the state Medicaid program and promote access to dental care by supporting those who treat medically underserved populations in dental health professional shortage areas.
- Section 2. Transfers s. 1009.65, F.S., Medical Education Reimbursement and Loan Repayment Program and renumbered it to s. 381.402, F.S., as the Florida Reimbursement Assistance for Medical Education Program. Adds advanced practice registered nurses, physician assistants, mental health professionals, licensed practical nurses and registered nurses as eligible participants.



## SB 7016 Health Care cont. Chapter No. 2024-15, Laws of Florida

Section 46. Revises s. 1009.8962, F.S., Linking Industry to Nursing Education (LINE) Fund, to:

- Add an independent school, college, or university with an accredited program as defined in s. 464.003, F.S., which is in this state and licensed by the Commission for Independent Education.
- Increase the first-time passage rate on the National Council of State Boards of Nursing Licensing Examination from at least 70 percent for the prior year to 75 percent, based on a minimum of 10 testing participants. (Amend rule 6A-10.0352.)



# SB 7016 Health Care cont. Chapter No. 2024-15, Laws of Florida

Section 79. Effective July 1, 2024, appropriates \$5
million in General Revenue recurring funds to the
Department of Education for the purpose of
implementing the LINE Fund.



#### SB 7032 Education

 Section 1. Creates s. 1004.933, F.S., Graduation Alternative to Traditional Education (GATE) Program, as an alternative pathway to education and workforce opportunities for students aged 16 to 21, who dropped out of high school.



#### SB 7032 Education cont.

- Section 5. Creates s. 1009.711, F.S., GATE
   Scholarship Program, to reimburse eligible
   institutions for costs related to students enrolled in
   the GATE program. Creates reporting requirements.
   State Board of Education may adopt rules to
   implement this section.
- Section 6. Revises s. 1009.895, F.S., Open Door Grant Program, to add students enrolled in adult secondary education programs as eligible participants.



#### SB 7032 Education cont.

 Section 8. Creates s. 1011.804, F.S., GATE Startup Grant Program, to fund and support the startup and implementation of the GATE Program. The department shall administer the grants, determine eligibility, and distribute grant awards. Eligible institutions include school district career centers, charter technical career centers, or FCS institutions which offer the GATE program. The department shall prioritize grant proposals that combine adult basic education, adult secondary education, and career education programs at one location or allow students to complete programs through distance learning.

#### SB 7032 Education cont.

 Section 9. Creates s. 1011.8041, F.S., GATE Program Performance Fund, to reward institutions for documented success of students participating in the GATE Program. Subject to legislative appropriation, each participating institution must receive \$1,000 per student who completes the GATE Program with a high school diploma or equivalent and a credential on the Master Credentials List within 3 years. If funds are insufficient to fully fund the calculated total award, the funds will be prorated. The State Board of Education may adopt rules to implement this section.

# HB 217 College Campus Facilities in Areas of Critical State Concern Chapter No. 2024-50, Laws of Florida

- Section 1. Amends s. 1009.23, F.S., Florida College System institution student fees. Paragraph (f) is added to subsection (11) to read: (f) Capital improvement fee revenues may be used for the purposes authorized in s. 1013.40 (4).
- Section 2. Amends subsection (4)(a) of s. 1013.40, F.S., to increase the number of additional beds from 25 to 50 for employees, educators, first responders, and adds health care workers to the list of eligible occupants. Clarifies subsection (4)(b): State operating funds, state performance funds, and revenues collected from the tuition, out-of-state fee, activity and service fee, financial aid fee, technology fee, and distance learning fee may not be used for construction, debt service payments, maintenance, or operation of such dormitories. Adds subsection (4)(c): Grants and donations for capital outlay and revenues from the capital improvement fee may be used for construction, debt service payments, maintenance, or operation of such dormitories.



# HB 217 College Campus Facilities in Areas of Critical State Concern cont. Chapter No. 2024-50, Laws of Florida

- Section 2 continued. Amends subsection (4)(d) of section 1013.40, F.S., to state: Additional dormitory beds constructed after July 1, 2016, may not be financed through the issuance of bonds by the FCS institution; however, bonds may be issued by nonpublic entities as part of a public-private partnership between the college and a nonpublic entity. Before the issuance of any such bonds, the Division of Bond Finance shall analyze the financing and any issues raised by such analysis must be appropriately considered by the college.
- Section 3. Effective date July 1, 2024.



## HB 357 Special Observances Chapter No. 2024-65, Laws of Florida

 Amends s. 683.1475, F.S., to designate the month of November as "Veterans Appreciation Month" and encouraging everyone to observe the occasion by creating special programs and events to show appreciation for the veterans who have served the United States. (Effective July 1, 2024.)



# SB 522 Tallahassee Community College Chapter No. 2024-43, Laws of Florida

- Renames the college which serves Gadsden, Leon and Wakulla Counties as Tallahassee State College. (s. 1000.21 (5)(aa), F.S.)
- Signed by the Governor March 27, 2024.
- Effective date July 1, 2024.
