STUDENT COURSE SCHEDULE – REJECT RULES

17. If Course Number is a course number from the Courses That Do Not Generate FTE file (F71424) or School Number, Current Enrollment is 3450, then FTE Reported, Course must be 0000 and FEFP Program Number must be 999.
-record rejected-

EXAMPLE

The first record listed below would be loaded to the database assuming no other reject rule would cause its rejection. The second record would be rejected because the course is a study hall and the FEFP Program Number is not 999. The third record would be rejected because the course is a study hall and the FTE Reported, Course is greater than zero.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the database, the district must appropriately correct the element(s) listed in the edit and resubmit the records.

76. If Course Number begins with a number; and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730); other than 0200320, 0200335, 1700510, 2000350, 2000360, 2102360, 2102365, 2102370, 3027010 or 3027020; or
- FEFP Program Number is 300 and course number is 0200320, 0200335, 1700510, 2000350, 2000360, 2102360, 2102365, 2102370, 3027010 or 3027020;

then the Career and Technical Education/Adult General Education Program Code must be a valid program number, other than 9900010 or 9900099, for the Course Number submitted, as listed in file F61730.

If Course Number begins with three alphabetic characters followed by a zero in the fourth position, and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730);

then the Career and Technical Education/Adult General Education Program Code must be a valid program number for the Course Number submitted, as listed in file F61730.

If Course Number begins with one alphabetic character followed by a numeric digit, and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730);

then the Career and Technical Education/Adult General Education Program Code must be the same as the Course Number. –state validation-

DISTRICT RESPONSIBILITY

The district should verify the FEFP Program Number and the Course Number and correct if in error.

EXCEPTIONAL STUDENT – STATE VALIDATION RULES

35. If the Exceptional Student, IDEA Educational Environments code equals C, D, F, H, or P then the Exceptionality, Primary code and the Exceptionality, Other codes must not equal U, or must not equal T unless the student's is age is less than ten as of the first day of survey week 5 and the Grade Level is KG, 1, or 2.

The Exceptional Student record listed below which is marked with an asterisk would cause a message to be generated because the correct relationship does not exist between Exceptionality, Primary or Exceptionality, Other and Exceptional Student, IDEA Educational Environments.
