12. Entry (Re-entry) Code, PK-12 must be E01, E02, E2A, E03, E3A, E04, E4A, E05, E09, R01, R02, or R03 unless Survey Period Code is 3 or 5 and Term is Y, in which case the field should be Z-filled. -record rejected-

#### **EXAMPLE**

The first two records listed below would be loaded to the database assuming no other reject rule would cause their rejection. The third record would be rejected since the Entry (Re-entry) Code, PK-12 is an adult entry code reported for a PK-12 student. The fourth record would be rejected since the Survey Period Code is 3, the Term is Y, and the Entry (Re-entry) Code is E01.
