Overview

The Florida Department of Education (FDOE) has been a national leader in education reform for decades, and it continually seeks bold and innovative ways to hold students to the highest standards in the nation while providing students with a world-class education. The underlying intent of House Bill (HB) 807 (2019) is to drastically improve the quality of Florida's civics education throughout its K-12 education system. The bill called for a review of statewide civics education course standards to ensure Florida students have the highest quality civics education courses throughout the nation.

An online review system through EdCredible[®] was established to specifically review civics and government standards. This system utilized the same rubric originally employed for the highly successful Executive Order 19-32 English Language Arts and Mathematics standards review in 2019. The K-5, 6-8, and 9-12 standards review forms enabled reviewers to thoroughly evaluate and comment on each standard, as well as the option to provide an overall comment for each grade cluster of standards. The EdCredible[®] review system opened for reviews on June 5, 2020, and closed on August 5, 2020.

Data from the EdCredible[®] online review system were collected and analyzed after the review closed on August 5, 2020. The data included quantitative and qualitative ratings for each individual benchmark and overall comments for the K-5, 6-8 and 9-12 review forms.

For each K-12 benchmark, stakeholders had the option to select no change needed, revise standard, move standard or eliminate standard. Stakeholders were permitted to leave a comment to support each answer choice. A comment was required if revise standard, move standard or eliminate standard was selected by the reviewer.

Student performance standards in Florida establish the core content of the curricula to be taught and specify the core content knowledge and skills that K-12 public school students are expected to acquire. The Commissioner shall determine whether revisions are necessary and shall propose such revisions to the State Board of Education for adoption. The Specifications and Criteria document for the 2022-2023 instructional materials adoption cycle for Social Studies, including civics, are anticipated for public release in November 2021. We anticipate that State Board of Education action to adopt revisions to standards will be complete by summer 2021. Approval of new course descriptions, to include revised standards, is currently expected to be made by fall 2021. Rule <u>6A-1.09441</u>, F.A.C., permits the Commissioner of Education to approve additional courses and course descriptions; such additional course listings will be made available as approved.

Themes

During a review of the feedback, the following themes emerged as priorities for civics education.

Theme 1:	Students should study primary source documents to understand the philosophical underpinnings of the American Republic and the root cause of American exceptionalism.
Theme 2:	Students should compare the success of the United States and the success or failure of other nations' governing philosophies to evaluate their past, present and likely future effects.
Theme 3:	Students should have a sense of civic pride and participate regularly in all levels of government.
Theme 4:	Students should reflect upon United States civic history so they understand their rights and responsibilities as citizens, including the process of advocating properly with government officials.

Next Steps

The Department will convene a workgroup of Florida experts to propose revised standards that reflect the themes identified in this report.

Expert Groups

Per Rule <u>6A-1.09401</u>, F.A.C., *Student Performance Standards*, the standards review process shall begin with convening an expert group to review the standards and make recommendations to the Commissioner for their review and revision. The HB 807 standards review expert group included representatives from Florida school districts and Florida College System (FCS) institutions.

Expert Group: Florida School Districts

On April 10, 2020, in a memo to superintendents the FDOE invited every Florida school district to submit one expert group nominee for grades K-5 and one expert group nominee for grades 6-12. Representatives from 48 of 73 school districts participated in the expert group review.

Public Reviews

HB 807 directed the FDOE to solicit feedback from educators, school administrators, postsecondary education representatives, elected officials, business and industry leaders, parents, and the public. Public reviews were encouraged through targeted email communications, promotion via social media, posting information on various pertinent FDOE webpages, and a memo to superintendents. There were 376 public reviewers that submitted feedback on https://www.floridacivicsreview.org/.
