PCC Chain of Lakes Collegiate High School's Accountability Plan addressed 10 goals, which included a total of 13 indicators. 12 of 13 or 92% of the indicators were met.

Goal 1: Earning College Credits

Goal 4: College Level Reading

School Response: While COL did not meet the performance outcome for this goal, the school had the second hightest mean score in the district and is one of two schools in Polk County that are in the top 100 mean high school scores in the State. Additionally, the percentage of COL students scoring at 3 or higher on the grade 11 FCAT Science is higher than all but one other school in Polk County (PCC's Lakeland CHS) and higher than its comparable schools.

Goal 7: Financial

Indicator 1 – PCC COL will have an unreserved/unrestricted fund balance of 5% of annual revenue as evidenced on the annual financial audit.
