Tip of the Week

Reduce Sources of Morning Stress, Sensory Overload

If a student with a disability routinely arrives to school frazzled or agitated, consider how to reduce the student's morning stress. For example, headphones on the bus ride to school may prevent a student with autism from experiencing sensory overload and may enhance the student's ability to retain information during morning lessons.(Special Ed Connection®)
